NOTICE OF OPPOSITION

Leki Lenhart GmbH, a corporation of Germany, with a business address at Karl-Arnold Strasse 30, Kirchheim/Teck 73230, Germany (“Opposer”), believes that it will be damaged by registration of the above identified trademark in Classes 18 and 25 and hereby opposes the same.

As grounds for opposition it is alleged that:

1. On February 16, 2015, Lumin Chen ("Applicant") filed an application seeking registration of the word mark LEKE (“Applicant’s Mark”), based on Applicant’s alleged use of the mark in commerce under Section 1(a) of the Trademark Act (15 U.S.C. Section 1051(a)). Said application was assigned Serial No. 86/536496 (“Applicant’s Application”).
2. Applicant’s Application covers numerous goods in Class 18 including all purpose sports bags, all purpose carrying bags, and walking sticks, and numerous goods in Class 25 including, ankle socks, athletic shoes, gloves, gloves as clothing and scarfs (hereinafter the full range of goods covered in these classes are referred to as

“Applicant’s Class 18 and Class 25 Goods”). Applicant's Application also covers goods in Class 22 which are not the subject of the instant Opposition.

3. In Applicant’s Application, Applicant claims December 10, 2014 as the date of the first use of Applicant’s Mark in U.S. commerce in connection with Applicant’s Class 18 and Class 25 Goods.
4. Opposer is the owner of Registration Nos. 1423012, 2028900 and 2756438 ("Opposer's Registrations") all for the word mark LEKI ("Opposer's Mark"). TSDR printouts of these registrations are attached as Exhibit A. The goods covered by Opposer's Registrations are as follows:

(The combined goods listed above are referred to herein as "Opposer's Goods".)

5. Opposer commenced use of Opposer's Mark in connection with Opposer's Goods well in advance of the filing date of Applicant's Application and in advance of the claimed dates of first use claimed in Applicant's Application. In addition Opposer's Registrations issued in advance of Applicant's claimed dates of first use.
6. On information and belief, Opposer's Mark has priority over Applicant's Mark.
7. Applicant's Class 18 and Class 25 Goods are identical to or closely related Opposer's Goods and are likely to travel within the same channels of trade.
8. Registration of Applicant's Mark, which is highly similar to Opposer's Mark and which is used in connection with goods which are identical to or closely related to Opposer's Goods is likely to cause confusion, mistake, or deception of purchasers as to the source of Applicant's Goods and is likely to falsely suggest a common association, sponsorship or origin of said goods between Applicant and Opposer, all to Opposer's irreparable damage and injury.
9. Applicant's Mark should be precluded from registration under Sections 2(d) of the Trademark Act because it so resembles a trademark previously used and registered by Opposer and not abandoned as to be likely when used on or in connection with the Applicant's Class 18 and Class 25 Goods to cause confusion, to cause mistake, or to deceive.

WHEREFORE, Opposer believes that it has a real interest in this proceeding and will be irreparably damaged by the registration of the Applicant's Mark, and respectfully requests that the Board sustain this Opposition and refuse the registration of the Applicant's Mark.
