NOTICE OF OPPOSITION

Opposer Twentieth Century Fox Film Corporation (“Opposer” or “Fox”) is a corporation of the State of Delaware having a principal place of business at 10201 West Pico Boulevard, Los Angeles, California 90035. Opposer believes that it is being damaged, and will be damaged, by the registration of Applicant NutraClick, LLC’s HOMELAND NEWS mark shown in Application Serial No. 86449185, and hereby opposes the same. As grounds for opposition, Opposer alleges that, upon actual knowledge with respect to Opposer’s own acts, and upon information and belief as to other matters:

Opposer and its HOMELAND Mark

1. Twentieth Century Fox Film Corporation, through itself and its related companies (collectively, “Opposer” or “Fox”), is one of the world’s leading and largest entertainment and media companies. Fox routinely offers and sells a wide variety of collateral merchandise, including clothing, in connection with its entertainment, film, and television programs and series.

2. On October 2, 2011, Fox first aired its ongoing television series, HOMELAND, on its Showtime cable network. The HOMELAND television series has received extensive critical and popular acclaim, and its cast and crew have garnered a number of prestigious awards over the years, including Emmy, Golden Globes, and Peabody Awards. Moreover, HOMELAND has earned a loyal fan base. Indeed, due to the popularity and success of HOMELAND, Fox recently renewed the series for a sixth season.

3. HOMELAND is a dramatic television series that follows an American CIA agent and her participation in intelligence operations seeking to thwart potential terror activities in the United States and abroad. The show uses real life news and other current events as inspiration for this fictional thriller.

4. Opposer's HOMELAND series is available on Showtime, and it is also available for streaming on its website, on Hulu, and through other third-party streaming services.

5. In addition to its HOMELAND television series, Opposer provides news and information about its HOMELAND show online at <http://www.sho.com/sho/homeland/home> and through mobile apps, among other things.

6. Since at least November 4, 2011, Opposer has used its HOMELAND mark in commerce in connection with pre-recorded DVDs, downloadable audio and video recordings, and downloadable television shows, among other things.

7. Since at least April 30, 2012, Opposer has used the HOMELAND mark in commerce in connection with calendars, posters, and books.

8. Since at least December 2013, Opposer has used the HOMELAND mark in commerce in connection with magnets.

9. Opposer’s HOMELAND mark has for many years received extensive unsolicited media attention nationwide, including but not limited to appearing in major U.S. publications, radio programs, and television programs such as *NBC News*, *MSNBC*, *CNN*, *NPR Morning Edition*, *CBS News*, *The Chicago Tribune*, *The Wall Street Journal*, *The Washington Post*, *Newsday*, *The Los Angeles Times*, *The Hollywood Reporter*, *The New York Times*, *The San Francisco Chronicle*, *San Jose Mercury News*, *Variety*, *USA Today*, *The New York Post*, *CNN Wire*, *Business Wire*, *The Dallas Morning News*, *The Boston Globe*, *The Seattle Times*, *The St. Louis Dispatch*, among others.

10. Through its long use of Opposer’s HOMELAND mark, great commercial success under that mark, substantial advertising and promotion under that mark, and extensive media attention and publicity under that name and mark, Opposer has developed valuable goodwill in its HOMELAND mark, and it has long been famous.

Opposer’s Registration Rights in its HOMELAND Mark

11. Opposer owns the following valid and subsisting United States trademark registrations for its HOMELAND mark (printouts from the PTO TSDR and assignment database are attached as Exhibit A).

12. The above registrations are valid and subsisting and constitute *prima facie* evidence of, Opposer’s ownership of and exclusive rights to use these marks in commerce in connection with the products and services recited in the registrations. (Collectively, the marks set forth in Paragraphs 2-11 are referred to as “Opposer’s HOMELAND Mark” and the goods and services listed in those paragraphs are collectively referred to as “Opposer’s Goods and Services.”)

Applicant and its HOMELAND NEWS Mark

13. Applicant Nutraclick, LLC (“Applicant”) is a limited liability company of Delaware, having an address of Suite 301, 24 School Street, Boston, Massachusetts 02108.

14. Applicant is the listed owner of Application Serial No. 86449185 (the “Application”), filed on November 10, 2014, under Section 1(b), 15 U.S.C. § 1051(b), for the mark HOMELAND NEWS for:

Providing an Internet website featuring general news and information in the fields of business and political issues in Class 35

Providing an Internet website featuring general news and information in the field of finance in Class 36

Providing a website featuring information and news in the field of current events relating to politics, justice, technology, health, science, music, art,

living/lifestyle, travel, opinion, finance, business, sports, investigative journalism in Class 41

Providing an Internet website featuring general news and information in the fields of health and nutrition in Class 44

Providing an Internet website featuring general news and information in the fields of social justice, diverse human cultures, beliefs, and lifestyles in Class 45

(referred to as “Applicant’s Mark” and the services listed in the Application are referred to as “Applicant’s Services”).

Likelihood of Confusion, 15 U.S.C. § 1052(d)

15. Opposer repeats and realleges each and every allegation set forth above.

16. Opposer has priority based on its valid and subsisting registrations for and prior use in commerce of Opposer’s HOMELAND Mark in connection with Opposer’s Goods and Services before the filing date of the Application, and any date of first use that may be alleged by Applicant.

17. Applicant’s Services are identical and highly related to Opposer’s Goods and Services. In particular, the Application covers “providing a website featuring information and in the field of current events related to politics, justice, technology, health, science, music, living/lifestyle, travel, opinion, finance, business, sports, investigative journalism” among others. Opposer’s Goods and Services also cover “providing on-line information in the field of television and video entertainment featuring drama via the Internet.” Moreover, the Application identification is so broad that it legally covers news and information pertaining to Opposer, Opposer’s HOMELAND Mark, and Opposer’s Goods and Services.

18. Applicant's HOMELAND NEWS mark so resembles Opposer's registered and prior used HOMELAND Mark, as to be likely, when registered and used in connection with Applicant's Goods and Services, to cause confusion, or to cause mistake, or to deceive under Section 2(d) of the Lanham Act, as amended, 15 U.S.C. § 1052(d).

Dilution, 15 U.S.C. § 1125(c)(1)

19. Opposer repeats and realleges each and every allegation set forth above.

20. Opposer has engaged in extensive, nationwide advertising, promotion, and use of its distinctive HOMELAND Mark. Further, Opposer has had substantial sales of Opposer's Goods and Services in connection with its Opposer's HOMELAND Mark over the years.

21. Opposer's HOMELAND Mark has for many years received extensive media attention and publicity nationwide. Such extensive and frequent media attention and publicity has had a substantial impact on the public, and has long created an association in the minds of consumers between Opposer, Opposer's HOMELAND Mark and Opposer's Goods and Services.

22. Opposer's HOMELAND Mark is a strong and distinctive mark that became famous, as defined under Section 43(c)(1) of the Lanham Act, 15 U.S.C. § 1125(c)(1), well before both the filing date of the Application, and any date of first use alleged by Applicant.

23. In view of the similarities of the parties' marks and the fame of Opposer's HOMELAND Mark, Applicant's HOMELAND NEWS mark so closely resembles

Opposer's famous mark that it is likely to cause dilution by blurring of the distinctive quality of such mark.

WHEREFORE, Opposer believes that it will be damaged by the registration of the mark shown in Application Serial No. 86449185, and requests that the opposition be sustained on all grounds, and that registration to Applicant be refused.
