Parties' stipulated motion filed July 11, 2016 to reopen applicant's time to file its answer and to suspend this proceeding for 30 days is granted.

Because the parties are negotiating for a possible settlement of this case, proceedings are suspended up to, and including August 11, 2016, subject to the right of either party to request resumption at any time. *See* Trademark Rules 2.117(c), and 2.127(a); and TBMP § 605.02.

In the event that there is no word from either party concerning the progress of their negotiations, upon conclusion of the suspension period, proceedings shall resume without further notice or order from the Board, upon the schedule set forth below.
