NOTICE OF OPPOSITION

G.H. Mumm & Cie., Societe Vinicole de Champagne Successeur, 29 rue du Champ de Mars, Reims, F51100, FRANCE, a Société Anonyme (SA) duly organized and existing under the laws of France, (“G.H. Mumm” or “Opposer”) through its attorneys, believes that it would be damaged by the registration of the mark shown in the above-identified application, and hereby opposes same, pursuant to 15 U.S.C. § 1063 and 37 C.F.R. § 2.104.

As grounds for opposition, it is alleged that:

(1) G.H. Mumm is and has been engaged in the sale and marketing of highly related goods to those recited by Applicant in its application to register since a time prior to the date of Applicant’s application date.

(2) G.H. Mumm is and has been engaged in the sale and marketing of goods under the registered trademarks MUMM, G.H. MUMM, G.H. MUMM & CIE, and G.H. MUMM & CO, among others, since at least as early as 1853.

(3) G.H. Mumm is the owner of the following valid and subsisting U.S. trademark registrations and applications:

(4) G.H. Mumm has used its MUMM Marks in commerce extensively and has acquired a considerable and valuable goodwill and widescale recognition for its marks. The public has come

to associate MUMM Marks, with Opposer and Opposer's goods and services, including but not limited to champagne, wines, sparkling wines, and alcoholic beverages.

(5) G.H. Mumm's registrations are prima facie proof of ownership and use of the mark from the original date of filing of the applications, pursuant to 15 U.S.C. 1057(b), and of the exclusive right to use the registered mark in commerce. Furthermore, Registration Numbers 3,242,831; 3,831,100; 3,336,798 and 312,427 are incontestable, pursuant to section 15 of the Trademark Act.

(6) Applicant's mark is confusingly similar to G.H. Mumm's registered trademarks and applications and is likely, when applied to Applicant's services to cause confusion, or to cause mistake or to deceive. *See* 15 U.S.C. § 1052(d). Applicant's mark makes a highly similar commercial impression to Opposer's mark due to its incorporation of the word "mum," a term phonetically identical and nearly and is nearly identical in appearance to Opposer's MUMM marks. The overall commercial impression of Applicant's mark, when applied to related goods or services, would cause confusion or be likely to cause confusion, mistake, or deception.

(7) Applicant seeks registration in International Class 043 for café, restaurant and food/beverage services, which are highly related to G.H. Mumm's goods, since cafés and restaurants often serve champagne and other beverages.

(8) G.H. Mumm has used its MUMM Marks in commerce extensively and has acquired a considerable and valuable goodwill and widescale recognition for its marks. The public has come to associate the MUMM Marks with Opposer and Opposer's goods and services.

(9) On information and belief, use of the MUM MUM mark by Applicant for services in Class 043 will cause confusion, mistake and deception with respect to those services by virtue of the Opposer's prior use and fame of its MUMM Marks.

(10) On information and belief, both Applicant's mark and G.H. Mumm MUMM Marks are applied to highly related goods and are likely to be sold to the same or similar channels of distribution. Applicant's mark so resembles G.H. Mumm MUMM Marks, which are well-known trademarks, as used in the United States and not abandoned, as to be likely to cause confusion, or to cause mistake or to deceive.

(11) Opposer has used the MUMM Marks on goods that are highly related to the services recited by Applicant in its application, since a time prior to Applicant's filing date for its mark.


(12) Applicant's actions would substantially harm Opposer, by permitting registration in favor of Applicant for a mark which the Opposer used on its goods from an earlier date.

(13) Opposer's MUMM Marks are famous marks and were famous prior to Applicant's filing date of its application.

(14) Applicant's mark dilutes or is likely to dilute the distinctive character of the MUMM Marks.

OPPOSER G.H. Mumm prays that this application Serial No. 86/675,673, be refused, that no registration be issued thereon to Applicant and that this Opposition be sustained in favor of G.H. Mumm.
