**OPPOSER'S NOTICE OF OPPOSITION**

Opposer Luxury Goods International (LGI) S.A., a corporation duly organized and existing under the laws of Switzerland, with an address of Via Industria 19 6814, Cadempino ("LGI" or "Opposer"), believes that it would be damaged by the registration of the mark shown in the above-identified application, and hereby opposes the same, pursuant to 15 U.S.C. § 1063 and 37 CFR § 2.104.

As grounds for opposition, it is alleged that:

1. LGI is and has been engaged in the sale and marketing of similar and highly related goods and services to those recited by Applicant in its application Serial No. 86/609,829 since a time long prior to the date of filing of Applicant's above application for registration.

2. LGI is and has been engaged in the sale and marketing of a variety of goods, including clothing, jewelry, eyewear, fashion accessories, handbags and leather goods, among others, under the interlocking YSL Mark since at least as early as 1980.

3. LGI is the owner of the entire right, title, and interest in the following valid, subsisting, and un-cancelled United States Federal trademark registrations (the "YSL Marks"):

YSL	Registration No.	0766417
YSL & Design	Registration No.	1208578
YSL & Design	Registration No.	1711127
YSL	Registration No.	1712999

(See Exhibits 1-4, attached)

and others (collectively referred to in the opposition as the YSL Marks).

4. LGI has used its YSL Marks in commerce extensively and has acquired a considerable and valuable goodwill and wide scale recognition for its marks. The public has come to associate the YSL Marks and its spoken equivalent "YSL" word marks, with Opposer and Opposer's goods and services, including but not limited to clothing, jewelry, leather goods, bags, eyewear and accessories.

5. LGI's registrations are prima facie proof of ownership and use of the YSL Marks from the original date of filing of the application, pursuant to 15 U.S.C. § 1057(b), and of the exclusive right to use the registered mark in commerce. Furthermore, Registration Nos. 766,417,

1,208,578, 1,711,127 and 1,712,999 are incontestable, pursuant to section 15 of the Trademark Act.

6. Applicant's mark is confusingly similar to LGI's registered trademarks and is likely, when applied to the goods of the Applicant, to cause confusion, or to cause mistake or to deceive. 15 U.S.C. § 1052(d).

7. Applicant's mark makes a highly similar commercial impression to LGI's Marks due to its incorporation of the interlocking letters Y, S, and D, and the arrangement of the letters with the Y emphasized, the S in the foreground and the D in the background, in such a manner as to appear as YSD, creating a virtually identical sound and appearance

8. The marks, as perceived by the consumer, will be considered identical, and confusing.

9. Applicant has appropriated significant portions of LGI's Marks.

10. The overall commercial impression of Applicant's mark, when applied to the same or similar goods, would cause confusion or be likely to cause confusion, mistake, or deception.

11. LGI has used its YSL Marks in commerce extensively for products in a variety of Classes, including but not limited to Classes 006, 009, 014, 016, 018, and 025. By virtue of such use, LGI has acquired a considerable and valuable goodwill and wide scale recognition for its YSL Marks. The public has come to associate the YSL Marks, with Opposer and Opposer's goods.

12. Opposer has used its YSL Marks in advertising and marketing of its goods, which form a major component of the Opposer's brand marketing efforts in the U.S. and abroad.

13. Opposer's YSL Marks have acquired distinctiveness.

14. On information and belief, use of the Applicant's mark for goods in Class 014 will cause confusion, mistake and deception with respect to those goods and services, by virtue of the Opposer's prior use of the YSL Marks on identical goods, and based upon fame of its YSL Marks.

15. On information and belief, both the Applicant's mark and LGI's YSL Marks are applied to identical goods and are likely to be sold to the same or similar channels of distribution.

16. The Applicant's mark employs a letter Y and S and D which interlock in a way which creates a confusingly similar impression to the Oposer's YSL Marks..

17. Applicant's mark is presented in an interlocking and stylized form which arrays the letters in such a way as to create a striking similar commercial impression to the Opposer's YSL Marks and interlocking YSL registrations and well-known trademarks, as used in the United States and not abandoned, as to be likely to cause confusion, or to cause mistake or to deceive.

18. Opposer has used the YSL Marks on highly related and/or identical goods to those recited by Applicant in its application, since a time prior to Applicant's filing date for its mark.

19. Applicant's actions would substantially harm Opposer, by permitting registration in favor of Applicant for a mark which the Opposer used on its goods from an earlier date.

20. Opposer's YSL Marks are famous and well-known in the United States and throughout the world.


21. Opposer's YSL Marks were famous and well-known in the United States and throughout the world prior to the filing date of Applicant's application.

22. Upon information and belief, Applicant's mark dilutes or is likely to dilute the distinctive character of the YSL Marks, thus damaging the Opposer.

WHEREFORE, Opposer Luxury Goods International (LGI) S.A. prays that the application Serial No. 86/609,829 be refused, that no registration be issued thereon to Applicant, and that this Opposition be sustained in favor of Luxury Goods International (LGI) S.A.
