**NOTICE OF OPPOSITION**

Opposer Under Armour, Inc. (“Under Armour”) believes that it will be damaged by the registration of Application Serial No. 8663814 for the mark  for “group fitness class services; physical fitness instruction and strength training services” in Class 41. As grounds for its opposition, Under Armour alleges the following, upon actual knowledge with respect to itself and its own acts, and upon information and belief as to other matters:

**Under Armour, Its Products and Services, and Its Famous UA Logo**

1. Opposer Under Armour is a Maryland corporation with an address of 1020 Hull Street, Baltimore, Maryland, 21230.
2. Under Armour is one of the world’s most successful, popular, and well-known providers of performance apparel, footwear, accessories, sporting goods, and related goods and services. In 2015 alone, Under Armour sold more than \$3 billion worth of products.
3. Under Armour has continuously and extensively used its famous  logo (including the variations shown below) and has promoted it in connection with Under Armour’s extensive product line, including a full line of athletic clothing, footwear, and headwear;


accessories; fitness/calorie intake tracking mobile apps and gear; sports equipment; and related retail and other services:



Under Armour's rights in the  logo date back to at least as early as 1996.

4. The  logo is applied to virtually all (if not all) of Under Armour's products and services, and is prominently used in marketing, advertising, and other materials, including throughout Under Armour's website at [www.underarmour.com](http://www.underarmour.com), e.g.:



6. The  logo has also appeared on gift cards, on and in retail stores and displays, and in advertising and other materials, such as television commercials, billboards, stadium signage and displays, Internet banner ads and videos, and Under Armour's website.






7. Under Armour has also prominently featured the  logo in television commercials and promotional videos showcasing amateur and professional athletes (including

prominent athletes Stephen Curry, Bryce Harper, Michael Phelps, Lindsey Vonn, Tom Brady, Jordan Spieth, George St-Pierre, and Brandon Jennings ) engaging in athletic activities.

**Applicant and Its Mark**

9. Applicant Vita Athletics, LLC is a New Jersey limited liability company with an address at 320 Springfield Avenue, Summit, New Jersey 07901.

10. On May 21, 2015, Applicant filed Application Serial No. 86638154 for the mark

 for “group fitness class services; physical fitness instruction and strength training services” in Class 41 alleging a May 1, 2015 first-use-in-commerce date.

**Count One**  
**Likelihood of Confusion, 15 U.S.C. §1052(d)**

11. Under Armour repeats and realleges each and every allegation set forth in each of the preceding paragraphs.

12. Under Armour's rights in its  logo predate Applicant's May 21, 2015 filing date and alleged May 1, 2015 first-use-in-commerce date.

13. Applicant's  mark is so similar to Under Armour's prior used, filed, and/or registered  logo mark, and the goods/services covered by Under Armour's  logo mark and Applicant's  mark are related in such a way that it is likely that potential consumers would be confused or mistaken or deceived as to the source of the parties' respective goods/services under Section 2(d) of the Lanham Act, as amended, 15 U.S.C. § 1052(d).

**Count Two**  
**Dilution, 15 U.S.C. § 1125(c)**

14. Under Armour repeats and realleges each and every allegation set forth in the preceding paragraphs.

15. Under Armour's  logo is famous, as that term is used in 15 U.S.C. § 1125(c), and was famous long before Applicant's May 21, 2015 filing date and/or alleged May 1, 2015 first-use-in-commerce date based on, among other things, the inherent distinctiveness and federal registration of Under Armour's  logo and the extensive nationwide use, advertising, promotion, and recognition of that mark.

16. Applicant's  mark so resembles Under Armour's famous  logo mark that it is likely to dilute the distinctive quality of Under Armour's  logo in violation of

Section 43(c) of the Lanham Act, 15 U.S.C. § 1125(c), as amended by the Trademark Dilution Revision Act of 2006.

WHEREFORE, Under Armour believes that it will be damaged by the registration of the mark shown in Application Serial No. 86638154, and respectfully requests that the opposition be sustained and that registration to Applicant be refused.
