NOTICE OF OPPOSITION

Opposer, Kimberly-Clark Worldwide, Inc. (hereinafter “K-C” or “Opposer”), a Wisconsin corporation, with its principal place of business in Neenah, Wisconsin, believes it will be damaged by registration of the purported mark HUGGIES SUPREME in whole as identified in Applicant’s application Serial No. 86-807423 (the “Subject Application”) and hereby opposes same.

FACTS

A. Opposer and the Famous HUGGIES Mark

1. Opposer has for many years been engaged in the manufacture, advertising, promotion, and sale of a wide variety of infant care products, including, but not limited to, disposable diapers and baby wipes.
2. Opposer is a Wisconsin corporation with a business address of 2300 Winchester Road, Neenah, Wisconsin 54956.
3. The HUGGIES trademark is displayed prominently on product packaging as well

as on the products themselves.

4. In addition to being reproduced on millions of dollars of product packaging sold in the U.S. alone, the HUGGIES mark also is featured extensively in all forms of media. Opposer uses the HUGGIES mark in advertisements that appear in national magazines with wide circulation, on television, and on the Internet. Opposer spends millions of dollars in advertising featuring the HUGGIES mark annually which is seen throughout the country.

5. In addition to Opposer's own advertising efforts, the HUGGIES mark receives significant unsolicited media coverage addressing the history of the brand and the trust and reliability mothers of babies and children place in the HUGGIES branded products.

6. Opposer has invested a substantial amount of time, effort and money in promoting the HUGGIES mark and in ensuring the high quality of goods provided under the HUGGIES brand.

7. Opposer owns the following federal trademark registrations, among others, for the HUGGIES mark:

All of the listed registrations are valid, subsisting, and in full force and effect, and serve as *prima facie* evidence of Opposer's ownership of the listed marks and its exclusive right to use each of the marks. In addition, all of the registrations are incontestable as to all goods and services listed herein under Section 15 of the Lanham Act, 15 U.S.C. §1065, meaning that the registration is conclusive evidence of Opposer's exclusive right to the registered marks in commerce on or in connection with the goods or services stated in the registration, as provided by Section 33(b) of the Lanham Act, 115 U.S.C. §1115 (b). Printouts from the United States Patent and Trademark Office's online database reflecting the registrations identified above are attached as Exhibit A and are made part of the records in these proceedings.

8. By virtue of the use and promotion of its HUGGIES mark for over 39 years and the sale and promotion of products under the HUGGIES mark, the mark HUGGIES has come to be recognized as identifying baby and child products and services finding their origin exclusively in or otherwise associated with Opposer, is distinctive of Opposer's goods and services, and has come to represent enormous goodwill of Opposer.

9. Opposer's extensive use of the HUGGIES mark, the unsolicited media coverage concerning Opposer and Opposer's sales and promotion of goods and services under the HUGGIES mark, have made the HUGGIES mark famous and distinctive in the United States.

10. By virtue of its registrations for and use of the HUGGIES mark, Opposer has

standing to bring this opposition.

B. Applicant and His Application

11. Upon information and belief, Applicant is an individual with a principal address of 6286 Paynes Point Road, Neenah Wisconsin 54956.

12. The Subject Application opposed herein was filed on November 3, 2015, and seeks to register the purported mark HUGGIES SUPREME for use in connection with “sex dolls” in International Class 10 (the “Identified Goods”).

13. The Subject Application was published for opposition in the *Official Gazette* on April 5, 2016. Opposer is allowed until May 5, 2016 to file this Notice of Opposition. Thus, this Notice of Opposition is timely filed.

14. Upon information and belief, Applicant was on actual notice of Opposer’s prior rights in the HUGGIES trademark before seeking to register the identical mark, HUGGIES, for the listed goods, “sex dolls.” As a matter of law, based on Opposer’s federal trademark registrations for its HUGGIES trademark, Applicant was deemed on constructive notice of Opposer’s rights in the HUGGIES mark.

15. There is no relationship between Applicant and Opposer and Opposer has never authorized or consented to Applicant’s use or application to register the HUGGIES mark opposed here.

16. Applicant’s mark HUGGIES SUPREME is identical to Opposer’s registered and prior used HUGGIES mark.

17. Applicant’s application and the presumption of exclusivity that would come from a registration to Applicant of the HUGGIES mark sought to be registered is inconsistent with the prior rights of Opposer in the HUGGIES mark and Opposer’s statutory grant of rights flowing

from its own trademark registrations.

COUNT I: CLAIM FOR RELIEF UNDER 15 U.S.C. 1052- DILUTION

18. Opposer incorporates by reference paragraphs 1-17 as if fully set forth herein.

19. Section 2 of the Lanham Act, 15 U.S.C. §1052, as amended on August 5, 1999, provides that trademark applications may be opposed if the mark applied for is likely to cause dilution as set forth in Section 43(c) of the Lanham Act, 15 U.S.C. §1125(c).

20. Opposer's HUGGIES mark is famous and well-known throughout the United States, having been used, advertised and publicized extensively throughout this country for over 39 years for baby and child care products, including, but not limited to, disposable diapers and baby wipes. The HUGGIES mark is inherently distinctive, has become associated exclusively with Opposer by reason of Opposer's extensive advertising and use of the mark for decades on or in connection with a wide variety of products, is the subject of numerous federal trademark registrations, is widely recognized by the general consuming public as a designation of source for Opposer's goods and services.

21. Applicant's application is based on intent to use and its filing date is long after Opposer's trademark became famous. Of note, Applicant also filed HUGGIES, Serial No.: 86-801810 on October 28, 2015, for "disposable pads for diaper changing" in International Class 16 (which has a pending refusal based on a likelihood of confusion with Opposer's registered marks) and HUGGIES ORIGINAL, Serial No.: 86-804150 on October 29, 2015, for "baby wipes" in International class 3 (which was expressly abandoned after being refused because of a likelihood of confusion with Opposer's registered marks).

22. By virtue of the facts, that Applicant's applied-for mark is virtually identical to Opposer's famous, registered, and long used HUGGIES mark, registration of the HUGGIES

SUPREME mark to Applicant inevitably will call to mind Opposer and would therefore dilute or would be likely to dilute Opposer's HUGGIES mark by impairing the distinctness of Opposer's HUGGIES mark to identify exclusive goods and services from Opposer. Moreover, Applicant's applied-for mark is for the goods "sex dolls" which is likely to cause dilution by tarnishment of the Opposer's famous mark. Accordingly, registration of the mark shown in the application herein opposed violates the Lanham Act, 15 U.S.C. §1125 (c).

23. By reason of the foregoing, Opposer will be damaged by the registration of the mark HUGGIES SUPREME by Applicant.

COUNT II: CLAIM FOR RELIEF UNDER 15 U.S.C. §1052 (d) – LIKELIHOOD OF
CONFUSION

24. Opposer incorporates by reference paragraphs 1-23 as if fully set forth herein.

25. Opposer's rights in the HUGGIES mark were established long prior to the filing date of Applicant's application for HUGGIES SUPREME herein opposed.

26. Applicant seeks to register HUGGIES SUPREME which is virtually identical to Opposer's trademark which has long designated Opposer's goods for babies and children.

27. Applicant's use of the proposed trademark HUGGIES SUPREME for the Identified Goods is likely to create the erroneous impression that Applicant's products originate from or are otherwise associated with Opposer, that Opposer is responsible for the goods or that Applicant's use of Opposer's very trademark HUGGIES is endorsed by or is in some way connected with Opposer all to Opposer's injury and harm.

28. Registration of the HUGGIES SUPREME mark in connection with the goods set forth in the opposed application is likely to cause confusion, cause mistake or to deceive the public into the false belief that the goods offered by Applicant under the HUGGIES SUPREME

mark come from or are otherwise sponsored by or connected with Opposer in violation of Section 2(d) of the Lanham Act, 15 U.S.C. §1052(d).

29. By reason of the foregoing, Opposer will be damaged by the registration of the mark HUGGIES SUPREME to Applicant.

WHEREFORE, Opposer respectfully requests that this opposition be sustained and that registration sought by Application Serial No. Serial No. 86-807423 be denied.

Opposer requests such other and further relief as the Board may deem just and proper.
