
Opposer and its MULAN Mark

3. Since at least 1998, Opposer, through its predecessors, related companies, and licensees, has used its MULAN trademark (“MULAN Mark”) in commerce in connection with its famous *Mulan* films and franchise. Opposer’s first *Mulan* animated film was released on June 19, 1998 to critical acclaim, being nominated for two 1999 Golden Globe Awards including Best Original Score and Best Original Song and for the 1999 Academy Award for Best Music, Original Musical or Comedy Score. Over its lifetime, the *Mulan* animated film has grossed over hundreds of millions of dollars worldwide. The immense success of the *Mulan* animated film led to the creation of a *Mulan* franchise, including the sequel *Mulan II* (2004), additional films and books, and a vast array of merchandise. Opposer’s *Mulan* was re-released in a 15th Anniversary Edition in 2013, and sold as part of a two-movie collection with *Mulan II*. Opposer’s MULAN Mark has been prominently used in connection with its films and DVD’s shown below, and on advertising and promotional materials for the films.



4. Since at least 1998, Disney has used its MULAN Mark in commerce in connection with video games, such as *Mulan* (1998) for Nintendo Game Boy and *Mulan* (1999) for PlayStation. Mulan and other characters from Disney’s *Mulan* franchise also appear in *Kingdom Hearts II* (2006) for PlayStation 2.

5. As early as 1998, Disney used its MULAN Mark in commerce for cosmetics and beauty care products. Representative samples of such products prominently displaying the MULAN Mark and the character from Disney’s *Mulan* franchise are shown below.



7. The above registrations are valid and subsisting and constitute *prima facie* evidence of Opposer's ownership of and exclusive rights to use these marks in commerce on the products recited in the registrations.

Applicant and its MULAN V BEAUTY Mark

8. Applicant Freestyle Records Inc. ("Applicant") is a company with an address of 5042 Wilshire Blvd, #555 Los Angeles, California 90036.

9. Applicant is the listed owner of Application Serial No. 86683349 (the "Application"), filed on July 5, 2015 under Section 1(b), 15 U.S.C. § 1051(b), for the mark MULAN V BEAUTY for "cosmetics; body and beauty care cosmetics perfumes" in Class 3 ("Applicant's Goods").

10. On February 2, 2016, the Application was published for opposition in the *Trademark Official Gazette* (TMOG), and Opposer timely filed on March 1, 2016 an extension of time to oppose.

Likelihood of Confusion, 15 U.S.C. § 1052(d)

11. Opposer repeats and realleges each and every allegation set forth in Paragraphs 1 through 10 above.

12. Opposer has priority based on its valid and subsisting registrations for Opposer's MULAN Marks. Opposer also has priority based on its prior common law use of Opposer's MULAN Marks in commerce in connection with Opposer's Goods and Services before the filing date of the opposed Application and any date of first use that may be alleged by Applicant.

13. Applicant's Goods are identical and highly related to Opposer's Goods

and Services.

14. Applicant's MULAN V BEAUTY Mark so resembles Opposer's previously used and famous MULAN Marks as to be likely, when registered and used in connection with Applicant's Goods, to cause confusion, or to cause mistake, or to deceive under Section 2(d) of the Lanham Act, as amended, 15 U.S.C. § 1052(d).

WHEREFORE, Opposer believes that it will be damaged by the registration of the mark shown in Application Serial No. 86683349, and requests that the opposition be sustained, and that registration to Applicant be refused.
