**NOTICE OF OPPOSITION**

The Opposer, LA REDOUTE ("Opposer"), a corporation organized under the laws of France, and located at 57 RUE DE BLANCHEMAILLE, ROUBAIX, FRANCE 59100, believes that it will be damaged by registration of the mark shown in the above-identified application, and hereby opposes the same.

As grounds for opposition, it is alleged that:

1. The Applicant, Textilian International Inc ("Applicant"), a corporation of New York, with an address of 837 Avenue Z, Brooklyn, NEW YORK 11235, has filed an application to register the "REROUTE" mark for use in connection with "Clothing, namely, tops, bottoms, jackets, and headwear" in International Class 025. Said application was filed on November 28, 2015, under Section 1(a) of the Trademark Act, was assigned U.S. Application No. 86/833,228, and was published for Opposition in the Official Gazette on May 3, 2016. Applicant's application was filed based on use of the mark claiming a date of first use of at least as early as October 24, 2015, and a date of first use in commerce of at least as early as October 30, 2015.

2. Opposer is a leading manufacturer and seller of various products, including various types of clothing and apparel in International Class 025.

3. Commencing long prior to Applicant's filing date and alleged date of first use in commerce, Opposer has engaged, and is now engaged in the manufacture, distribution, sale, advertising and promotion in interstate commerce of clothing and apparel in International Class 025.

4. In connection therewith, Opposer is the owner of the "LA REDOUTE" mark, (hereinafter "Opposer's Mark"), U.S. Reg. No. 1,389,593, registered on April 15, 1986, for "wearing apparel for men, women, and children-namely, shirts, pants, sweaters, socks, jackets, dresses, coats, hats scarves, gloves, underwear, shoes, and slippers" in International Class 025. This mark was filed September 27, 1982 and claims a priority date of May 27, 1982. *See* [Exhibit A, U.S. Reg. No. 1,389,593].

5. Opposer's May 27, 1982 priority date and September 27, 1982 filing date for Opposer's Mark is prior to the November 28, 2015 filing date and October 30, 2015 alleged first use in commerce date of Applicant's "REROUTE" mark, Application No. 86/833,228.

6. Opposer's first use date of Opposer's Mark and prior filing and registration date of Opposer's "LA REDOUTE" trademark gives Opposer's Mark priority of use over Applicant's mark.

7. Applicant's "REROUTE" mark would be confusingly similar because:

- a. the mark is confusingly similar in appearance to Opposer's Mark;
- b. the mark is confusingly similar in sound to Opposer's Mark;
- c. the mark is confusingly similar in connotation to Opposer's Mark;
- d. the goods of Opposer and the goods of Applicant are closely related and/or marketed through the same or overlapping channels of trade and/or to the same classes of consumers;
- e. Opposer's Mark enjoys a high level of distinctiveness.

8. Opposer has made a substantial investment in advertising and promoting its goods under Opposer's Mark throughout the world and in the United States. Opposer has extensively used, advertised, promoted and offered Opposer's goods bearing Opposer's Mark to the public throughout the world and in the United States through various channels of trade in commerce, with the result that Opposer's customers and the public in general have come to know and recognize Opposer's Mark and associate the same with Opposer and/or goods sold by Opposer. As a result of such extensive use and advertisement, Opposer's customers and the public in general will in the future know and recognize Opposer's Mark and associate the same with Opposer and/or the goods sold by Opposer.

9. Opposer's Mark constitutes the lawful, valued, subsisting, and exclusive property of the Opposer. As a result of the high quality of Opposer's goods that are sold under Opposer's Mark, and the extensive sales and advertising made under Opposer's Mark throughout the world and in the United States, the aforementioned mark has become an intrinsic and essential part of the valuable goodwill and property of Opposer, and is recognizable and associated by the public as a symbol identifying and distinguishing Opposer's goods as those of exceptional quality.

10. Applicant's "REROUTE" Mark, U.S. Application No. 86/833,228, so resembles Opposer's Mark as to be likely to cause confusion or mistake, to suggest a connection, or to deceive purchasers into believing that Applicant's goods originate with the Opposer and/or are endorsed or sponsored by the Opposer, and/or that Applicant and/or its goods are otherwise affiliated with the Opposer and its goods and services.

11. Use of Applicant's "REROUTE" mark will inexorably have an adverse effect upon the value of Opposer's Mark. If this Opposition is not sustained, any defect, objection to, or fault

found with Applicant's goods and services provided under the "REROUTE" mark would necessarily reflect on and seriously injure the valuable goodwill and reputation that Opposer has established, and will establish, for its goods and services.

12. Based on the foregoing arguments, registration of the mark "REROUTE" for use in connection with "Clothing, namely, tops, bottoms, jackets, and headwear" in International Class 025, as found in U.S. Application No. 86/833,228, filed on November 28, 2015, and published for Opposition in the Official Gazette on May 3, 2016, will cause injury and damage to Opposer.

WHEREFORE, Opposer respectfully requests that the Trademark Trial and Appeal Board find and order that registration by Applicant of the mark "REROUTE" in class 025 be denied as damaging to the Opposer and that this opposition is sustained.

Opposer hereby submits the requisite filing fee of \$300.00 for opposing Applicant's application in International Class 025.
