

**NOTICE OF OPPOSITION AND REQUEST TO
CONSOLIDATE WITH RELATED OPPOSITION**

Opposer, Match.com, L.L.C. (“Match.com”), a limited liability company existing under the laws of the state of Delaware and having an address of P.O. Box 25458, Dallas, Texas 75225, believing it will be damaged by registration of **MATCH FACTOR** as a trademark in International Class 45 for “*Dating services; Dating services provided via mobile applications and web services; Dating services, namely, providing an on-line computer database featuring single people interested in meeting other single people; Internet based social networking, introduction, and dating services; Internet-based*”

dating, social introduction and social networking services; Internet-based social networking services; Marriage partner introduction or dating services; Marriage proposal consulting in the nature of assisting others in the planning of marriage proposals; On-line social networking services; Online social networking services accessible by means of downloadable mobile applications; Providing a website featuring information regarding dating; Providing on-line computer databases and on-line searchable databases in the field of social networking; Web site services featuring on-line dating club” as shown in Serial No. 86814444, hereby opposes same. In addition, Match.com requests that this Opposition be consolidated with Opposition No. 91227941, which matter involves the same parties, the same marks, and the same issues.

As grounds for opposition, Match.com alleges as follows:

1. Applicant, Match Media Group LLC, seeks registration of MATCH FACTOR as a trademark in International Class 45 for “*Dating services; Dating services provided via mobile applications and web services; Dating services, namely, providing an on-line computer database featuring single people interested in meeting other single people; Internet based social networking, introduction, and dating services; Internet-based dating, social introduction and social networking services; Internet-based social networking services; Marriage partner introduction or dating services; Marriage proposal consulting in the nature of assisting others in the planning of marriage proposals; On-line social networking services; Online social networking services accessible by means of downloadable*

mobile applications; Providing a website featuring information regarding dating; Providing on-line computer databases and on-line searchable databases in the field of social networking; Web site services featuring on-line dating club (“the Subject Services”).

2. Applicant filed Application Serial No. 86814444 on November 9, 2015, claiming use of the mark for the Subject Services since at least as early as November 12, 2014.

3. Match.com is the owner of a family of “MATCH” trademarks relating to online dating and/or related services (collectively the “MATCH Marks”), including the following registered marks or pending applications:

The MATCH Marks also include a variety of common law “MATCH” trademarks that Match.com has also used over the years, including MUTUAL MATCH, REVERSE MATCH, and MATCHPHONE.

4. Match.com, its licensees, and/or its predecessors-in-interest, have used the MATCH Marks in interstate commerce in connection with online dating and social interaction and/or related services since at least as early as March 1995, well before the filing or first use date of Application Serial No. 86814444.
5. Match.com, its licensees, and/or its predecessors-in-interest, have invested significant resources advertising and promoting goods and services sold under the MATCH Marks, and has used the marks in connection with the millions of dollars worth of goods and services. As such, consumers and others view the MATCH Marks as a famous family of marks, and regard Match.com as the origin of goods or services sold under the “MATCH” designation, especially in the field of online dating. The MATCH Marks acquired distinctiveness, fame, and renown among consumers and the public well before Applicant’s filing or first use date.
6. Upon information and belief, Applicant will offer the Subject Services under the MATCH FACTOR mark to a variety of customers, many of whom are likely to

- be familiar with, or actual purchasers or users of, services offered or provided by Match.com under one or more of its MATCH Marks.
7. Applicant's MATCH FACTOR mark appropriates Match.com's MATCH mark in its entirety. The inclusion of the term "FACTOR" is unlikely to dispel confusion
 8. Applicant's proposed use of MATCH FACTOR in connection with the Subject Services is thus likely to cause consumers mistakenly to believe that such services are related to Match.com or the MATCH Marks, or that such services originate from, or are sponsored or approved by, Match.com (or vice versa). This confusion and mistake is likely to cause injury to Match.com.
 9. If Applicant is awarded a registration for MATCH FACTOR in connection with the Subject Services as shown in Serial No. 86814444, it would also be entitled to the presumptions flowing from such a registration, all to the injury of Match.com.
 10. Concerned about the potential for confusion and for harm, Match.com timely filed this Notice of Opposition within the prescribed statutory period.
 11. Match.com has not given Applicant permission to use the MATCH FACTOR mark, or to incorporate the MATCH designation into any mark.

12. Accordingly, registration for the mark applied for under Serial No. 86814444 should be refused under the provisions of Section 2(d) of the Trademark Act.
13. Applicant was not using the MATCH FACTOR mark in commerce for or connection with the provision of the Subject Services as of November 9, 2015, the filing date of Application Serial No. 86814444.
14. Applicant Serial No. 86814444 was therefore void *ab initio* when filed.
15. Accordingly, registration for the mark applied for under Serial No. 86814444 should be refused under the provisions of Section 1(a) of the Trademark Act.

WHEREFORE, Opposer, Match.com, L.L.C., prays that Application Serial No. 86814444 be rejected, that no registration be issued to Applicant, and that this opposition be sustained in favor of Match.com.

REQUEST TO CONSOLIDATE

Opposer, Match.com, L.L.C., requests pursuant to Federal Rule 42(a) that this Opposition be consolidated with Opposition No. 91227941, which matter involves the same parties, the same marks, and the same issues. *Cf.* D.I. 1 (Opp. No. 91227941). Consolidation of the two cases would save the parties and the Board time, effort, and expense, and no party would suffer prejudice or inconvenience as a result. Thus, Opposer respectfully submits that consolidation is both appropriate and warranted here.
