NOTICE OF OPPOSITION

Ricardo Media, Inc. (“Opposer”), a corporation of Canada with a business address at 300, rue d’Arran, Saint-Lambert, Quebec J4R1K5, Canada, believes that it will be damaged by registration of the above identified trademark and hereby opposes same.

As grounds for opposition it is alleged that:

1. Opposer owns Reg. Nos. 4915877 and 4906588 for the mark RICARDO covering various goods and services in Classes 8, 16, 21, 24, 25 and 41 (“Opposer’s Marks”). Status and title copies of Opposer’s Marks are attached to this pleading.
2. The underlying applications for Opposer’s Marks were filed on December 23, 2009.
3. Opposer owns and operates the domain name <ricardocuisine.com>. This domain was registered in 2007 and is currently active.
4. By virtue of the distribution, sale, advertising and promotion of products and services bearing Opposer’s Marks, they have become widely recognized by the relevant public as identifying goods and services produced and offered exclusively by Opposer.
5. On May 12, 2015, Cisneros Corporation (“Applicant”), a corporation of Delaware having a business address at 2020 Ponce de Leon Blvd., PH-2, Coral Gables, Florida

33134, USA, filed an application seeking registration of the mark

 (“Applicant’s Mark”) covering:

Digital media, namely, CD’s, DVD’s, downloadable files featuring photographs and files relating to photography, in Class 9

Printed matter, namely, books, pamphlets, notepads, photographs and stationery, in Class 16

Clothing, namely, shirts, t-shirts, blouses, slacks, bathing suits, hats, sweaters, neckties and jackets, in Class 25

Publishing services, namely, online and electronic publishing, publication of books, magazines and promotional materials; providing a website featuring photographs from social media, in Class 41

This application was assigned Serial No. 86/627117.

6. Applicant’s earliest claimed date of first use of its Mark in US commerce is alleged to be August 2010.
7. Opposer has priority based on its 2009 filing dates.
8. Applicant’s Mark contains the term RICARDO which is identical to Opposer’s Marks.
9. Applicant’s mark is visually and phonetically similar to Opposer’s Marks.
10. Applicant’s Mark in its entirety evokes a substantially similar commercial impression to Opposer’s Marks.
11. Applicant’s Mark is confusingly similar to Opposer’s Mark.
12. The goods and services covered by Applicant’s Mark are commercially related to the goods and services covered by Opposer’s Marks, thus source confusion is likely.
13. The respective goods and services covered by Applicant’s Mark and Opposer’s Marks often emanate from a single source, thus source confusion is likely.

14. The Parties' respective goods and services are likely to be marketed through the same channels of trade, thus consumer confusion is likely.
15. Opposer's goods and Applicant's services are likely to be marketed and directed to the same classes of prospective purchasers, thus source confusion is likely.
16. Applicant's Mark is confusingly similar to Opposer's Marks in sight, sound and overall commercial impression. Additionally, Applicant's trade channels and end consumers overlap with those of Opposer. Accordingly, use and registration of Applicant's Mark is likely to deceive and to cause mistake or confusion among members of the public as to the source of Applicant's services within the meaning of 15 U.S.C. §1052(d).

WHEREFORE, Opposer believes that it has a real interest in this proceeding and will be irreparably damaged by the registration of the Applicant's Mark, and respectfully requests that the Board sustain this Opposition and refuse registration of same.

Opposer requests that the requisite filing fee of \$1,200 be charged to the undersigned's Deposit Account No. 010035-6336.
