NOTICE OF OPPOSITION

Opposer, Top Shop/Top Man Limited (“Opposer”), a company organized and existing under the laws of the United Kingdom and having an address at Colegrave House, 70 Berners Street, London W1T 3NL, United Kingdom, believes that it would be damaged by issuance of a registration for the trademark POPSHOP ...BY I.N.GLOBAL & Design (“Applicant’s Mark”) as applied for in Application Serial No. 86/717,087 (the “Application”) by Idea Nuova, Inc. (the “Applicant”). Accordingly, Opposer, by and through its attorneys, hereby opposes the same and, as grounds for opposition, alleges as follows:

1. Opposer is the owner and operator of the internationally renowned TOPSHOP chain of retail stores and the www.topshop.com website, where it advertises and sells a wide

range of clothing and accessories bearing Opposer's famous TOPSHOP and TOP SHOP names and marks (collectively, the "TOPSHOP Marks"). Opposer, through its predecessors-in-interest, began using its TOPSHOP Marks in the United Kingdom no later than 1964, and began using the TOPSHOP Marks in the United States no later than 1998, and continues to use such marks. On or about April 2, 2009, Opposer opened its first stand-alone TOPSHOP store in the United States and now has retail stores in New York, Los Angeles, Chicago and Las Vegas. Through Opposer's extensive sales, advertising and promotion activities, and through the significant publicity it receives *via* the national and international press and the media, consumers worldwide, including in the United States, have long had familiarity with Opposer's TOPSHOP Marks and associate the TOPSHOP brand for clothing, clothing sales, and fashion exclusively with Opposer.

2. Opposer advertises and promotes its products and services extensively through many forms of media, including, but not limited to, advertisements in internationally circulated publications, in printed and electronic catalogs, and on the internet at www.topshop.com. Opposer's TOPSHOP brand has been featured in magazines and journals such as Lucky, US Weekly, InStyle, Vogue, People, the New York Times, and the Wall Street Journal, and is worn by celebrities such as Kate Bosworth, Nicole Richie, Cameron Diaz, Kelly Osbourne, Selma Blaire, Amanda Bynes, Juliette Lewis, Mariah Carey, Fergie, Lake Bell, Ashlee Simpson, Mary-Kate Olsen, Kate Moss, Keira Knightly, and Sienna Miller.

3. Opposer has expended considerable resources towards establishing and protecting its valuable TOPSHOP Marks worldwide and owns trademark registrations for them in, among others, the following countries: Australia, Austria, Bahrain, Belgium, Brunei Darussalam, Bulgaria, China, Croatia, Cyprus, Czech Republic, Denmark, Estonia, Finland, France, Germany,

Gibraltar, Greece, Guernsey, Hong Kong, Hungary, Iceland, Indonesia, Ireland, Israel, Italy, Japan, Jersey, Jordan, Latvia, Lebanon, Lithuania, Luxembourg, Malta, Monaco, Morocco, Netherlands, New Zealand, Peru, Philippines, Poland, Portugal, Qatar, Republic of Korea, Romania, Russian Federation, San Marino, Saudi Arabia, Serbia, Singapore, Slovakia, Slovenia, South Africa, Spain, Sweden, Switzerland, Taiwan, Thailand, Tunisia, Turkey, Ukraine, United Arab Emirates, United Kingdom, United States and Yemen (collectively, the “Foreign Registrations”). All of the Foreign Registrations are valid and subsisting and in full force and effect in connection with clothing, accessories, retail store services and related goods and services.

4. Opposer also owns many U.S. Registrations for its TOPSHOP Marks, including, but not limited to, U.S. Registration Nos. 3237860, 3524207, 3524208, 3552730, 3655345, 3673939, 3807075, 3810903, 4000555, and 4420216 (collectively “Opposer’s U.S. Registrations”) in connection with clothing, footwear, jewelry, sunglasses, accessories, luggage, bags, soaps and detergents, retail store and online retail store services, and other goods (“Opposer’s Goods and Services”). Opposer’s U.S. Registrations are valid, subsisting and in full force and effect and some have achieved incontestable status. Opposer has also acquired significant common law rights in its TOPSHOP Marks in connection with Opposer’s Goods and Services. True and correct copies of the Opposer’s U.S. Registrations are attached as Exhibit 1. True and correct printouts from the U.S. Patent and Trademark Office’s (“USPTO”) Status & Document Retrieval database and Trademark Electronic Search System, showing the current status and title for the Opposer’s U.S. Registrations, are attached hereto as Exhibit 2.

5. Additionally, on March 14, 2011—well before Applicant filed its Application—Opposer filed Serial No. 85/265,793 for TOPSHOP SPACE in connection with a wide variety of

goods in International Classes 11, 20, 21, 24 and 27, including textile goods, bed and table covers, bed sheets, bed blankets, bed throws, bed linen, quilts, and textile table cloths. On August 2, 2016, Opposer also filed Serial No. 87/124,807 for TOPSHOP in connection with bed, bath, table and household linen; table mats; bed spreads; eiderdowns; curtains; rugs; handkerchiefs; throws; flannels; pelmets; and quilts in International Class 24 (collectively, “Opposer’s Applications”).

6. Opposer’s Applications demonstrate its intention to further expand its use of the TOPSHOP Marks to a wide variety of linens, sheets, blankets, table cloths, and other textiles.

7. On August 6, 2015, Applicant filed the intent-to-use Application to register Applicant’s Mark in the USPTO for bed and table linen, bed covers, bed sheets, bed throws, sheet sets, and table and bed linen in International Class 24 (“Applicant’s Goods”).

8. Opposer’s rights in the TOPSHOP Marks arose prior to any alleged rights of Applicant in Applicant’s Mark.

9. Opposer obtained from this Board extensions of time to oppose the Application, allowing Opposer until August 14, 2016 (a Sunday) to oppose the Application.

COUNT I
(Likelihood of Confusion)

10. Opposer realleges and incorporates herein by reference the matters alleged in Paragraphs 1 through 9.

11. Opposer’s TOPSHOP Marks are strong as demonstrated by Opposer’s widespread and continuous use of the marks, and the extensive promotion, advertising and sales of Opposer’s Goods and Services under Opposer’s TOPSHOP Marks, substantial unsolicited publicity Opposer receives, as well as other factors.

12. POPSHOP, the dominant portion of Applicant's Mark, is nearly identical to Opposer's TOPSHOP Marks. It differs by only one letter and has the same number of letters and syllables. Therefore, Applicant's Mark is similar in sound and appearance to Opposer's TOPSHOP Marks and creates a similar commercial impression.

13. Applicant is seeking to register Applicant's Mark in connection with identical goods or goods that are closely related to Opposer's Goods and Services and the goods listed in Opposer's Applications. Further, the expansion of the TOPSHOP Marks to various types of linens and textiles is within Opposer's reasonable zone of expansion, as evidenced by Opposer's Applications. Because other well-known retail-store chains have also expanded their brands to various types of linens, textiles, and other home goods, the public is likely to believe that Applicant is associated with, licensed, sponsored or approved by Opposer.

14. Given that Applicant's Goods are the same or closely related to those of Opposer's, they are likely to be marketed in the same channels of trade to the same consumers.

15. Applicant's Mark, when applied to Applicant's Goods, is likely to cause confusion, mistake or deception by causing the public to believe that Applicant's Goods originate from, or are otherwise sponsored or endorsed by Opposer in violation of Section 2(d) of the Lanham Act, 15 U.S.C. § 1052(d), with consequent damage to Opposer and the public within the meaning of 15 U.S.C. § 1063(a).

REQUEST FOR RELIEF

16. For the foregoing reasons, among others, Opposer believes that it would be damaged by the registration of Applicant's Mark. Accordingly, Opposer respectfully requests that this opposition be sustained and registration of Applicant's Mark be denied.
