**NOTICE OF OPPOSITION**

Opposer United Industries Corporation, a Delaware corporation with its principal place of business located at One Rider Trail Plaza Drive, Suite 300, Earth City Missouri 63045 (“Opposer”), believes that it will be damaged by registration of the PEST REPELLETS mark, as shown in Application Serial No. 86815449 (the “Application”), owned by Huma.Ne (“Applicant”), and published in the *Official Gazette* on May 3, 2016. Opposer timely obtained an extension of time to oppose and now states the following grounds for its opposition to the Application:

1. Opposer is a leading supplier of insect repellent products, personal care products, lawn and garden care products, insect control products, and household insecticides, among others.
2. Opposer is the owner of all rights in the well-known REPEL trademark, which it and its predecessors-in-interest (collectively, “UIC”) have used continuously in United States commerce for decades in connection with insect repellent products, personal care products, lawn and garden care products, insect control products, household insecticides, and related products (the “REPEL Mark”), and since long prior to the Application’s claimed August 5, 2015 date of first use in commerce or the Application’s November 10, 2015 filing date.

3. As a result of UIC's long and continuous use of its REPEL Mark in connection with its insect repellent products, personal care products, lawn and garden care products, insect control products, household insecticides, and related products, and as a result of UIC's extensive advertising and promotion of its goods under the REPEL Mark, the consuming public and the trade have come to recognize the REPEL Mark as belonging to UIC, and associate and identify the goods offered under the REPEL Mark with UIC. UIC consequently derives invaluable goodwill and value from this recognition, association, and identification by the consuming public and the trade.

4. In addition to its strong common law rights in the REPEL Mark, Opposer is the owner of Registration No. 1285753 of the REPEL Mark (the "REPEL Registration"). The REPEL Registration specifies "insect repellent" in International Class 5 as the goods for which the REPEL Mark is registered. The REPEL Registration was issued on July 17, 1984 and claims a date of first use of November 15, 1968.

5. The REPEL Registration is valid and subsisting, and has been registered on the Principal Register for more than five years. In accordance with 37 C.F.R. § 2.122(d)(1), the certificate of registration and an electronic copy of the record from the USPTO's online TSDR database, demonstrating the current status and title of the REPEL Registration, are attached collectively as **Exhibit A**.

6. Because of the high degree of distinctiveness of the REPEL Mark, the length of time and extent to which UIC has used the REPEL Mark, the advertising and publicity the REPEL Mark has received, the substantial trading area in which the REPEL Mark is used, and the high degree of consumer recognition of the REPEL Mark, the REPEL Mark is a well-known and strong trademark, deserving of a broad scope of legal protection.

7. On November 10, 2015, Applicant filed an application with the U.S. Patent and Trademark Office (“USPTO”) to register the mark PEST REPELLETS in standard character format for “pest repellent made from diatomaceous earth granules and natural oils” in International Class 5, from which the term “PEST” has been disclaimed (Serial No. 86815449) (“Applicant’s Mark”), claiming August 5, 2015 as the date of first use in commerce of Applicant’s Mark.

8. The goods recited in the Application are highly related to and/or overlapping with the goods that Opposer currently provides in intrastate and interstate commerce in connection with its REPEL Mark, and which UIC has provided for decades prior to any actual or constructive use date of Applicant’s Mark. Moreover, the goods recited in the Application also are highly related to and/or overlapping with the goods identified in the REPEL Registration.

9. Applicant’s Mark is very similar in sight, sound, appearance, and commercial impression to the REPEL Mark. Indeed, Applicant’s Mark incorporates the entirety of the REPEL mark.

10. Applicant had constructive knowledge and, on information and belief, also had actual knowledge of the REPEL Mark prior to adopting Applicant’s Mark.

11. Applicant had constructive knowledge and, on information and belief, also had actual knowledge of the REPEL Mark prior to filing the Application.

12. UIC has continuously used its REPEL Mark since before Applicant’s first use, actual or constructive, of the PEST REPELLETS mark shown in the Application.

13. Opposer will be damaged by registration of Applicant’s Mark because the mark so resembles the REPEL Mark as to be likely to cause confusion, mistake, and deception. Persons familiar with the REPEL Mark and the goods offered under the REPEL Mark would be likely to believe erroneously that Applicant’s goods are the goods of Opposer or are authorized,

endorsed, sponsored, or licensed by Opposer. Thus, registration of Applicant's Mark on the Principal Register would be inconsistent with UIC's strong prior rights in the REPEL Mark under 15 U.S.C. §§ 1052(d) and 1063.

WHEREFORE, Opposer requests that Application Serial No. 86815449 be refused in its entirety and that no registration issue thereon to Applicant and, further, that this Opposition be sustained in favor of Opposer.

The required \$300.00 opposition fee is being submitted electronically with this Notice of Opposition. The Director is authorized to debit Kilpatrick Townsend & Stockton LLP's Trademark Deposit Account No. 20-1430 for any deficiency in the required fee. Please recognize William M. Bryner, Sabina A. Vayner, and the law firm of Kilpatrick Townsend & Stockton LLP as attorneys for Opposer in connection with this opposition proceeding.

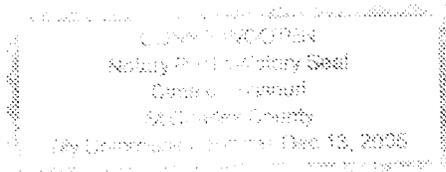
