NOTICE OF OPPOSITION

Cabel Hall Citrus Limited, (“Opposer”) believes that it will be damaged by the registration of the mark UGLY JUICE as shown in Serial No. 86899181 and hereby opposes the same. As grounds for its opposition, Opposer alleges as follows:

1. Opposer is a well-known exporter of citrus fruits from Jamaica. Opposer exports its fruits to countries around the world, including the United States, Canada, UK, European Union countries, Scandinavia and other Eastern Europe countries.
2. Opposer has sought and secured registration of its well-known UGLI trademark in a number of countries around the world. Opposer also runs an informational website located at www.ugli.com.
3. Opposer, through its predecessors in interest and licensees, has sold fruits under the UGLI brand in the United States since as early as 1955.
4. In addition to its common law rights in the UGLI trademarks, Opposer owns several federal registrations including:

The above registrations along with Opposer’s common law rights will collectively be referred to as the “UGLI Marks”.

5. Copies of the certificates of registration for the above mentioned registrations are attached as **Exhibit A**. These federal registrations are valid, subsisting, and in full force and effect. Further, Opposer’s rights to the above registrations are incontestable pursuant to 15 U.S.C. § 1065, and serve as conclusive evidence of the validity of the registered marks, of Opposer’s ownership of the marks, and of Opposer’s exclusive right to use the registered marks in commerce in connection with the goods and services referenced in the registrations (“Opposer’s Goods”). Further, Opposer’s registrations constitute constructive notice to others of Opposer's rights in and to the UGLI Marks.
6. Opposer has made significant investments to advertise and promote Opposer’s Goods in connection with the UGLI Marks and has established extensive goodwill in the UGLI Marks. The UGLI Marks are famous and distinctive and have acquired substantial secondary meaning in the minds of relevant consumers.
7. Notwithstanding Opposer’s prior rights in and to the UGLI Marks, VodkaCleanse, LLC (“Applicant”) filed, on February 5, 2016, an application to register the mark UGLY JUICE (“Applicant’s Mark”) in connection with “Fruit juice, vegetable juice, fruit-vegetable juice, non-alcoholic beverages containing fruit juice, non-alcoholic beverages

containing vegetable juice, cold pressed fruit juice, cold pressed vegetable juice” (“Applicant’s Goods”).

8. Applicant has entered a disclaimer of the term “juice” apart from the mark as shown.
9. As stated above, the subject application was filed on February 5, 2016, claiming an intent to use the mark in commerce. Opposer’s applications to register its UGLI Marks were filed, and resulting registrations issued well prior to the filing of the subject trademark application. Further, Opposer has substantial common law rights in the UGLI Marks dating back to 1955. Thus, the UGLI Marks have priority over Applicant’s Mark.
10. Applicant’s Mark wholly contains the phonetic equivalent of the dominant portion of Opposer’s UGLI Marks and is confusingly similar, in appearance, sound, and commercial impression, to the UGLI Marks. The registration and use of Applicant’s Mark by Applicant in association with Applicant’s Goods is likely to cause confusion as to the source or origin of Applicant’s Goods, and is likely to mislead consumers.
11. Applicant’s Goods are in part identical to and, at a minimum, closely related, to Opposer’s Goods. Upon information and belief, Opposer’s Goods and Applicant’s Goods will be offered to similar or overlapping classes of purchasers, and are likely to travel through the same channels of marketing and trade.
12. Applicant’s Mark, when used in connection with Applicant’s Goods, is likely to cause confusion, to cause mistake, and to deceive the public as to the approval, sponsorship or endorsement of Applicant’s Goods by Opposer. Accordingly, registration of Applicant’s Mark in connection with Applicant’s Goods would damage Opposer, and registration, therefore, should be refused pursuant to 15 U.S.C. §1052(d).

13. The UGLI Marks became famous before Applicant filed its intent-to-use application for the UGLY JUICE Mark on February 5, 2016.
14. Applicant's registration of Applicant's Mark is likely to cause dilution of Opposer's famous UGLI Marks, by lessening the capacity of the UGLI Marks to identify and distinguish Opposer's Goods and harming the reputation of the UGLI Marks, all to Opposer's detriment. Accordingly, registration should be refused based on a likelihood of dilution by blurring and tarnishment, pursuant to 15 U.S.C. §1125(c).
15. Opposer would be injured by the granting of the registration sought by Applicant in connection with Applicant's Goods as it would serve to confuse consumers, risk bringing Opposer into disrepute, and damage Opposer's goodwill in the UGLI Marks.

WHEREFORE, Opposer believes that it would be damaged by the registration of Application Serial No. 86899181 and prays that such registration be denied.
