NOTICE OF OPPOSITION

Opposer, the United States Olympic Committee (“USOC”), a congressionally chartered nonprofit organization limited liability company existing under the laws of the United States and having an address of 1 Olympic Plaza, Colorado Springs, Colorado 80909, believing it will be damaged by registration of **SUBARU RALLY TEAM USA (Stylized)** as a trademark in International Classes 3, 6, 10, 15, 18, 20, 21, 22, 25, 30, 35, and 41 as shown in Serial No. 86569391, hereby opposes same.

As grounds for opposition, the USOC alleges as follows:

1. Applicant, Fuji Jukogyo Kabushiki Kaisha, seeks registration of SUBARU RALLY TEAM USA (Stylized) as a trademark for “sunscreen cream; emery boards” (Cl. 3), “metal key chains” (Cl. 6), “Ear plugs for noise reduction” (Cl. 10), “Percussion instruments, namely, cowbells” (Cl. 15), “Umbrellas; backpacks; luggage tags; pouches made of cloth” (Cl. 18), “Chairs; stools; couches” (Cl. 20), “Plastic water bottles sold empty; cleaning cloths; candy tins sold empty for domestic use; cups; portable coolers” (Cl. 21), “lanyards for holding badges” (Cl. 22), “Clothing, namely, t-shirts, polo shirts and jackets; wind-jackets; hats” (Cl. 25), and “candy sold in tins” (Cl. 30) (collectively, “the Subject Goods”), as well as for “organizing of vehicle exhibitions for commercial or advertising purposes” (Cl. 35), and “Organizing vehicle exhibitions for entertainment purposes; entertainment services in the nature of automobile racing and exhibitions” (Cl. 41) (collectively, “the Subject Services”).
2. Applicant filed Application Serial No. 86569391 on March 19, 2015, claiming actual use of the mark in connection the Subject Goods and a *bona fide* intent to use the mark in commerce for the Subject Services.

The USOC, its licensees, and/or its predecessors-in-interest, have used the TEAM USA[®] Marks in interstate commerce for goods and services identified therein since before the filing date of Application Serial No. 86533115, as well as before any claimed date of first use as reflected in Application Serial No. 86533115.
5. The USOC, its licensees, and/or its predecessors-in-interest, have invested significant resources advertising and promoting goods and services sold under the TEAM USA[®] Marks, and have used the marks in connection with hundreds of millions of dollars’ worth of goods and services. As such, consumers and others view the TEAM USA[®] Marks as a famous family of marks, and regard the USOC as the source or origin of goods or services offered, provided, sold, or advertised under the “TEAM USA” designation. The TEAM USA[®] Marks acquired distinctiveness, fame, and renown among consumers and the public well before Applicant’s filing date and before any of Applicant’s claimed dates of first use.
6. The USOC also owns extensive common law trademark rights in the mark TEAM USA. For years, the USOC, and its predecessors-in-interest, have used the TEAM

USA trademark in connection with the Olympic Games and the USOC's merchandising, licensing, and sponsorship programs, and athletic services related to the Olympic Games. The USOC regularly seeks official sponsors for the U.S. Olympic Team and licenses the TEAM USA mark including to official automobile sponsors.

7. Upon information and belief, Applicant will offer the Subject Goods and Services under the SUBARU RALLY TEAM USA mark to a variety of customers, many of whom are already familiar with, or actual purchasers or users of, goods or services offered, provided, sold, or advertised by the USOC or its licensees under its TEAM USA[®] Marks.

8. Applicant's SUBARU RALLY TEAM USA mark appropriates the USOC's TEAM USA[®] mark in its entirety. The inclusion by Applicant of additional wording is unlikely to dispel confusion, especially in view of the stylization of the mark (shown below), which separates out the RALLY TEAM USA element:

SUBARU
RALLY TEAM USA

Not only does the addition of SUBARU fail to dispel confusion, but the combination of SUBARU plus TEAM USA only serves to mislead consumers into believing that Subaru is a sponsor of TEAM USA because consumers are

accustomed to seeing USOC marks in composite marks with official Olympic sponsors, including automotive sponsors. See, e.g., below:



Official Sponsor of Team USA

9. Applicant's proposed use of SUBARU RALLY TEAM USA in connection with the Subject Goods and Services is thus likely to cause consumers mistakenly to believe that such goods and services are related to the USOC or the TEAM USA[®] Marks, or that such goods and services originate from, or are sponsored or approved by, the USOC (or *vice versa*). This confusion and mistake is likely to cause injury to the USOC.

10. For example, consumers may mistakenly believe based on the subject mark that Applicant is a sponsor of the USOC, TEAM USA[®], or of the Olympic movement.

11. If Applicant is awarded a registration for SUBARU RALLY TEAM USA in connection with the Subject Goods and Services as shown in Serial No. 86569391, it would also be entitled to the presumptions flowing from such a registration, all to the injury of the USOC.
12. Concerned about the potential for confusion and for harm, the USOC timely filed requests for extensions of time to oppose the subject application and is now filing this Notice of Opposition within the prescribed statutory periods.
13. The USOC has not given Applicant permission to use the SUBARU RALLY TEAM USA mark, or to incorporate the TEAM USA[®] designation into any mark.
14. Accordingly, registration for the mark applied for under Serial No. 86569391 should be refused under the provisions of Section 2(d) of the Trademark Act.
15. On information and belief, Applicant was not using SUBARU RALLY TEAM USA (Stylized) as a mark for some or all of the Subject Goods as of the date Applicant filed Serial No. 86569391. Furthermore, Applicant is also believed to have lacked a *bona fide* intent to use SUBARU RALLY TEAM USA (Stylized) as a mark for some or all of the Subject Services as of the application filing date.

16. Accordingly, registration for the mark applied for under Serial No. 86569391 should be refused under the provisions of Sections 1(a) and/or 1(b) of the Trademark Act either in whole or in part for being void *ab initio* based on Applicant's lack of use of and/or lack of a *bona fide* intent to use the subject mark.
17. As a result of the USOC's long, extensive, and continuous use, as well other factors listed in Section 43(c) of the Trademark Act, the TEAM USA[®] mark has, since long prior to the filing date of Serial No. 86569391 or any of Applicant's claimed dates of first use, become famous within the meaning of Section 43(c) as identifying the USOC as the source or origin of goods or services offered, provided, sold, or advertised under the "TEAM USA" designation.
18. Applicant's use of SUBARU RALLY TEAM USA to identify the Subject Goods and Services would dilute the distinctive quality and harm the reputation of the famous TEAM USA[®] mark and, thus, is likely to cause dilution as set forth in Section 43(c) of the Trademark Act, both by blurring and by tarnishment, and injure the USOC.
19. Accordingly, registration for the mark applied for under Serial No. 86569391 should be refused under Sections 2 and 43(c) of the Trademark Act.

20. The TTAB has held that the USOC and the Olympic Games as a whole may be viewed as an institution pursuant to 15 U.S.C. § 1052(a). *In re Urbano*, 51 USPQ2d 1776 (TTAB 1999).
21. Applicant's use of SUBARU RALLY TEAM USA falsely suggests a connection with the USOC and/or the Olympic Games.
22. Accordingly, Application Serial No. 86569391 should be rejected under the provisions of Section 2(a) of the Lanham Act.

WHEREFORE, Opposer, United States Olympic Committee, prays that Application Serial No. 86569391 be rejected, that no registration be issued to Applicant, and that this opposition be sustained in favor of the USOC.
