**EXPENSIFY, INC.'S ANSWER TO NOTICE OF OPPOSITION &
AFFIRMATIVE DEFENSES**

Applicant, EXPENSIFY, INC. ("Expensify") hereby answers and responds to the Notice of Opposition ("Petition") filed on September 16, 2016, by Plaintiff EBB DEVELOPMENT LIMITED ("Opposer") as follows:

ADDITIONAL FACTS

Expensify is a San Francisco start-up company founded in 2009 with the purpose of making expense reporting simple. Expensify's technology enables paperless expense reporting. Users no longer need to attach paper receipts to printed expense reports. Expensify technology automates the process by point and click photo receipt capture,

automatic optical character recognition of the receipt, automatic classification of the receipt, and integration with a virtual expense report. Expensify summarizes this functionality as “Expense Reports That Don’t Suck!”

Expensify continues to expand its services offering. As part of that expansion Expensify has added CONCIERGE technology which automates business processes and employs optical character recognition (OCR) software for managing expense reporting, expense management, and itinerary management.

As such, Expensify began use on CONCIERGE in commerce online and on mobile phones at least as early as December 14, 2015, as shown below, and, almost two months prior to the Opposer’s purported Pakistani intent-to-use filing date of February 12, 2016. Pending full use of CONCIERGE on all of the goods and services, Expensify filed intent-to-use applications for CONCIERGE in International Classes 009, 042 (serial no. 86/906,603) and 035 (serial no. 86/906,606) for use on goods and services relating to automating various forms of expense management, itinerary management, and financial management. Below is an exemplar of actual use in commerce of CONCIERGE:

16. Expensify actually used CONCIERGE in commerce at least as early as December 14, 2015 in connection with Class 035 and series enumerated within its application. Accordingly, Expensify denies the allegations of paragraph 16.

17. Paragraph 17 states a legal conclusion and therefore no answer is required, however, should such an answer be required, Expensify denies the allegations contained within paragraph 17 and demands strict proof thereof.

18. Paragraph 18 states a legal conclusion and therefore no answer is required, however, should such an answer be required, Expensify denies the allegations contained within paragraph 18 and demands strict proof thereof.

19. Paragraph 19 states a legal conclusion and therefore no answer is required, however, should such an answer be required, Expensify denies the allegations contained within paragraph 19 and demands strict proof thereof.

20. Paragraph 20 states a legal conclusion and therefore no answer is required, however, should such an answer be required, Expensify denies the allegations contained within paragraph 20 and demands strict proof thereof.

AFFIRMATIVE DEFENSES

1. **THE OPPOSITION BASED ON SERIAL NO. 87/131,390 IS INVALID BECAUSE OPPOSER DID NOT HAVE A GOOD FAITH INTENT TO USE THE MARK AT THE TIME IT FILED ITS APPLICATION IN THE UNITED STATES.**

I. OPPOSER’S LARGE NUMBER OF INTENT TO USE TRADEMARK FILINGS AT THE USPTO & IN PAKISTAN INDICATES A LACK OF GOOD FAITH BONA FIDE INTENT TO USE.

A. On information and belief, according to The Registrar of Companies for England and Wales, Opposer is a company incorporated under the Companies Act 2006 as a private company limited by shares, No 08883537, with offices at 3rd Floor 207 Regent Street, London, United Kingdom, and holding a single share. The 2016 annual return of Opposer states that it consists of a single company director, Mr. Michael Gleissner, who owns that one share. Opposer describes its business as “Television programming and broadcasting activities,” referencing SIC 60200.

B. According to the USPTO website, Opposer is purported owner of GREENFOOT (Reg. No. 4806213) and has filed at least thirteen trademark applications in different classes for SELFIE, RAISE, GLASS, SUBZERO, YELLO, LEVEL 5, and CONCIERGE. *See* Table immediately below.

C. On information and belief, most of the applications listed above were filed within a two week window (8/8/2016 to 8/24/2016) by the same attorney, Jonathan Grant Morton.

D. Each application claims priority under 44(d) to intent-to-use applications filed in Pakistan approximately six months earlier (2/12/2016 to 2/24/2016), except LEVEL 5 which was filed in Benelux approximately six months earlier.

E. On information and belief, according to the USPTO website, these applications, all by the same owner, span nine unrelated classes of products, and services, namely International Classes 03, 09, 12, 21, 21, 28, 36, 41, and 42.

F. For example, on information and belief, according to the USPTO's website, Opposer filed four different applications for CONCIERGE across a spectrum of unrelated classes of products, and services, namely:

- In IC035 for “Advertising, business management and business administration, employment agency services; conducting skills evaluation for individuals; consultancy; office functions.” Serial No. 87131367.
- In IC009 for “Computer hardware; software; computer peripherals; electronic data processing installations; computer network apparatus; parts and fittings for all the aforesaid goods.” Serial No. 87131390.
- In IC042 for “Immigration consultancy services for corporations and individuals; immigration consultancy services in relation to obtaining visas.” Serial No. 87131399.

- In IC036 for “Financial services; investment services; fund and asset management; financial management and planning.” Serial No. 87132958.

G. In addition, Opposer filed four different applications for SELFIE across a spectrum of unrelated classes of products, including:

- In IC011 for “Apparatus for lighting, heating, steam generation, cooking, refrigerating, drying, ventilation, water supply and sanitary purposes.” Serial No. 87148595.
- In IC012 for “Vehicles; apparatus for locomotion by land, air or water.” Serial No. 87146938.
- In IC021 for “[h]ousehold or kitchen utensils and containers; combs and sponges; brushes; brush-making materials; articles for cleaning purposes; steelwool; unworked or semi-worked glass (except glass used in building). Serial No. 87148579.
- In IC028 for “[g]ames and playthings; gymnastics and sporting articles not included in other classes.” Serial No. 87149949.

H. Similarly, Opposer has applied for:

- YELLO in IC009 for “Computer Hardware; Computer Software; Computer peripherals; Electronic data processing installations; computer network apparatus; parts and fittings for all the aforesaid goods.”
- RAISE in IC036 for “Financial services; investment services; fund and asset management; financial management and planning.”
- SUBZERO in IC036 for “Tobacco; smoker’s articles; matches.”; and

- LEVEL 5 in IC009 for “Computer software; Computer peripherals; Electronic data processing equipment; Computer networking and data communications equipment; Computer components and parts.”

I. The sheer number of applications that Opposer filed for unrelated goods and services is evidence that it lacked a bona fide intent to use any of the referenced marks, and importantly, the CONCIERGE mark, as of the filing date of the application.

II. ALTER EGO ASSERTION - THE OPPOSITION BASED ON SERIAL NO. 87/131,390 IS INVALID BECAUSE MR. GLEISSNER, AT ALL TIMES HEREIN MENTIONED, DOMINATED, INFLUENCED AND CONTROLLED OPPOSER, AND THUS LACKS A GOOD FAITH BONAFIDE INTENT TO USE.

A. Expensify is informed and believes, and thereon alleges, that Mr. Gleissner was at all times relevant the alter ego of Opposer.

B. Expensify is informed and believes and thereon alleges that Mr. Gleissner, at all times herein mentioned, dominated, influenced and controlled Opposer and the officers thereof as well as the business, property, and affairs of Opposer.

C. Expensify is informed and believes and thereon alleges that, at all times herein mentioned, there existed and now exists a unity of interest and ownership between Mr. Gleissner and Opposer; the individuality and separateness of Mr. Gleissner and Opposer has ceased.

D. Expensify is informed and believes and thereon alleges that, at all times since the incorporation of Opposer, it has been and now is a mere shell and naked

framework which Mr. Gleissner used as a conduit for the conduct of his personal business, property and affairs.

E. Expensify is informed and believes and thereon alleges that, at all times herein mentioned, Opposer was created and operated by Mr. Gleissner, whereby the income, revenue and profits of Opposer was diverted by Mr. Gleissner to himself.

F. Expensify is informed and believes and thereon alleges that, at all times herein mentioned, Opposer was organized by said Mr. Gleissner as a device to avoid individual liability and for the purpose of substituting financially deficient corporations in the place and stead of Mr. Gleissner, and accordingly, Opposer was formed with capitalization totally inadequate for the business in which said corporation was engaged.

G. Expensify is informed and believes and thereon alleges that Opposer is undercapitalized, and thus is devoid of a lack of good faith bona fide intent to use.

H. By virtue of the foregoing, adherence to the fiction of the separate corporate existence of Opposer would, under the circumstances, sanction a fraud and promote injustice in that Expensify would be unable to realize a proper judgment in its favor.

I. Expensify is informed and believes and thereon alleges that, at all times relevant hereto, Mr. Gleissner and Opposer acted for each other in connection with the conduct hereinafter alleged and that each of them performed the acts complained of herein or breached the duties herein complained of as agents of each other and each is therefore fully liable for the acts of the other.

J. More specifically, the acts and intent of Mr. Gleissner should be imputed to the Opposer and the acts and intent of Opposer should be imputed to Mr. Gleissner, and further evidence a lack of a good faith bona fide intent to use.

III. FURTHER EVIDENCE OF A LACK OF A GOOD FAITH INTENT TO USE IS THAT MR. GLEISSNER IS OWNER/DIRECTOR/SOLE SHAREHOLDER IN OVER 76 COMPANIES (INCLUDING OPPOSER) HOLDING OVER 150 ITU TRADEMARK APPLICATIONS.

A. As noted above on information and belief, Opposer is owned by Michael Gleissner. Mr. Gleissner, according to Wikipedia, is an “entrepreneur, film producer, director, screenwriter, and actor.”¹ Mr. Gleissner’s personal website, describes him as “a distinct executive in today’s business of entertainment.”²

B. On information and belief, Mr. Gleissner is also the sole shareholder, director, and/or officer in at least seventy-six companies (“the Gleissner Companies”) each incorporated in the United Kingdom, and each sharing a common address at 3rd Floor 207 Regent Street, London, United Kingdom.

C. On information and belief each of the Gleissner Companies holds a single share valued at one British pound. Each Gleissner company consists of a single company director and officer, Mr. Michael Gleissner, who owns the single share outstanding.

D. On information and belief, each of the Gleissner Companies describes its business as “Television programming and broadcasting activities,” referencing SIC 60200.

E. On information and belief, the Gleissner Companies hold at least one hundred sixty-three United States intent-to-use trademark applications (“the Gleissner ITU Applications”). The Gleissner ITU Applications claim priority to foreign filed applications in Pakistan (46 applications), Portugal (36 applications), Benelux (50 applications), the United Kingdom (19 applications), and Germany (1 application). The Gleissner ITU Applications cover a wide and unrelated array of goods and services. *See* Exhibit 1 for at least a partial list of the companies and applications.

F. These 163 intent-to-use applications cover infamous names such as MADOFF & MADOV and ENRON, famous brands such as THE HOME DEPOT, city websites such as ROME.COM, SEOUL.COM, ANTWERPEN.COM, SINGAPORE.COM and TOKYO.COM, and descriptive or already famous terms such as PEPPER, SADDLE, VIVA, ARROW, XERO, YEAH & YEAH.COM.

G. Details of some of the more provocative applications include:

- MADOFF, Serial No. 87090543, to Madoff International Limited in IC0003, 0009, 0014, 0016, 0025, 0026, 0035, 0038, 0041, and 0042.
- MADOV, Serial No. 87088896, to Madov International Limited in IC003, IC009, IC014, IC016, IC025, IC036, IC035, IC038, and IC041. On information and belief the descriptions of goods and services for MADOV are materially identical to those described in MADOF.

- ENRON, Serial No. 87087225, to Enron International Limited in IC0003, 0009, 0016, 0025, 0026, 0035, 0038, and 0041.
- THE HOME DEPOT, Serial No. 87103171, to BNU Textiles Limited, in IC035 for “Advertising to the public, announcements and advertisements by any means of; advertising; business management; business administration; office functions.”

H. The sheer number of intent to use applications in such a large and unrelated number of classes filed by companies owned by Mr. Gleissner is strong evidence that there is no bone fide intent to use the CONCIERGE mark of the present application in the U.S.

2. THE OPPOSITION BASED ON SERIAL NO. 87/131,390 IS INVALID BECAUSE OPPOSER ASSIGNED ITS APPLICATION PRIOR TO FILING THE OPPOSITION

A. On information and belief, Opposer filed the opposition on September 16, 2016, based upon its intent-to use Application No. 87/131,390.

B. On information and belief, on September 6, 2016, ten days prior to filing the opposition, Opposer executed an assignment of all right, title and interest to the CONCIERGE ITU Application to Concierge Partners, Inc., another UK Private Limited Company at the same address as Opposer, recorded on September 18, 2016 at Reel/Frame 5880/0258 at the Recordals Branch of the United States Patent and Trademark Office.

C. Thus, as Opposer did not own rights to the application 87/131,390 upon which it stakes its claims to rights to file the opposition, Opposer has no standing.

D. On information and belief, Opposer's attorney JONATHAN GRANT MORTON represented both the Assignor, the Opposer, and the Assignee, so was aware of the assignment at the time of filing the Opposition.

E. On information and belief, Opposer's attorney JONATHAN GRANT MORTON prepared the assignment document, so was aware of the assignment at the time of filing the Opposition.

F. On Information and belief, Opposer's attorney JONATHAN GRANT MORTON prepared the Assignment Cover sheet and filed the Assignment for recordation on September 6, 2016, so was aware of the assignment at the time of filing the Opposition.

3. EXPENSIFY HAS PRIOR USE RIGHTS UNDER COMMON LAW.

A. Expensify used CONCIERGE in commerce at least as early as December 14, 2015, well before Opposer's purported foreign priority date of February 12, 2016.

B. Expensify had applied for trademark protection for CONCIERGE and had been using CONCIERGE in commerce at the time the Opposer signed the Oath for its intent-to-use trademark application Serial No. 87/131,367.

C. Expensify had, and does have, rights in CONCIERGE that are superior to any that Opposer may have.

4. EXPENSIFY HAS PRIOR INTENT-TO-USE RIGHTS.

A. Notwithstanding Expensify's prior actual use of CONCIERGE in commerce, Expensify's intent-to-use application is senior in right to Opposer's purported foreign priority date, for at least the following reasons:

1. Expensify filed its application earlier in the day on February 12, 2016 than Opposer filed its Pakistani application, thus Expensify has an earlier relative filing time than Opposer, thus Applicant has priority.

2. Expensify's application has a lower serial number, thus Applicant has priority.

3. Opposer's Pakistani application is defective, or insufficient, to establish the purported priority date, thus Applicant has priority.

5. OPPOSER COMES WITH UNCLEAN HANDS.

A. As evidenced by the excessive number of intent to use applications in relation to the number of products and services that Opposer is likely to introduce, Opposer has lack of a Bona Fide Intent to Use CONCIERGE, thus comes with unclean hands.

6. MR. GLEISSNER, AS THE ALTER EGO OF OPPOSER, COMES WITH UNCLEAN HANDS.

A. As evidenced by the excessive number of intent to use applications in relation to the number of products and services that Opposer is likely to introduce, Mr. Gleissner, Opposer's alter ego, has a lack of a Bona Fide Intent to Use CONCIERGE, thus comes with unclean hands.

7. FRAUD ON THE USPTO.

A. Opposer, Mr. Glessiner in his capacity as the sole member/shareholder/director of Opposer, Mr. Gleisnner in his capacity as the alter ego of Opposer, as well as the attorney of record, all committed fraud on the USPTO by their actions noted in Affirmative Defenses 1-6 and the introductory section.

B. Expensify had applied for trademark protection for CONCIERGE and had been using CONCIERGE in commerce at the time that Opposer signed the Oath for its intent-to-use trademark application.

C. Expensify had, and does have, rights in CONCIERGE that are superior to any that Opposer may have.

D. Opposer knew that Expensify had rights in CONCIERGE superior to Opposers and either believed that a likelihood of confusion would result from Opposer's use of its mark or had no reasonable basis for believing otherwise.

E. Opposer, in failing to disclose these facts to the Patent and Trademark Office, intended to procure a registration to which it was not entitled.

8. THERE IS NO LIKELIHOOD OF CONFUSION FOR USE OF CONCIERGE ON OPPOSER'S LISTED GOODS AND SERVICES WITH USE OF CONCIERGE ON EXPENSIFY'S LISTED GOODS AND SERVICES.

WHEREFORE, Expensify prays that the


1. Opposer and all persons or entities in privy, concert or alter ego with it take nothing.
