San Mar Corporation, a Washington corporation (“Opposer”), having a principal place of business at 22833 SE Black Nugget Road, Suite 130 Issaquah Washington 98029, believes that it will be damaged by the registration of the mark PORT DELUXE, which is the subject of Application Serial No. 86/781,795, published in the Official Gazette on April 12, 2016. Opposer hereby opposes the registration of said mark and requests that registration be refused. As grounds in support of its opposition, Opposer states as follows:

1. Opposer has continuously and regularly used the mark PORT AUTHORITY in connection with tote bags and various apparel items in interstate commerce and nationwide since at least as early as January 1, 1994. Opposer currently uses the PORT AUTHORITY mark for tote bags and apparel.

2. Opposer has continuously and regularly used the mark PORT AND COMPANY in connection with various apparel items in interstate commerce and nationwide since at least as

early as July 22, 1996 and with various types of blankets in interstate commerce and nationwide since at least as early as November 1, 1999. Opposer also currently uses the PORT AND COMPANY mark for bags.

3. Opposer has continuously and regularly used the mark PORT AUTHORITY SIGNATURE for various apparel items in interstate commerce and nationwide since at least as early as January 27, 2000. Opposer continuously and regularly used the mark PORT AUTHORITY SIGNATURE in connection with various carrying cases and various types of bags in interstate commerce and nationwide from at least as early as January, 2001 through at least as late as May, 2010. Opposer currently uses the PORT AUTHORITY SIGNATURE mark for various apparel items.

4. Opposer has continuously and regularly used the mark PORTFLEX for various headwear items in interstate commerce and nationwide since at least as early as August 2, 2004. Opposer currently uses the PORTFLEX mark for headwear.

5. As a result of Opposer's current and past promotion and sale of its products under the PORT AUTHORITY, PORT AND COMPANY, PORT AUTHORITY SIGNATURE, and PORTFLEX marks, those marks have gained significant recognition and goodwill among the purchasing public.

6. Opposer owns U.S. Trademark Registration No. 2,787,770, issued on December 2, 2003, for the mark PORT AUTHORITY for "Tote bags sold only to businesses and organizations for embellishment with the marks and logos of others" in International Class 18 and "Clothing, namely, aprons, sweatshirts, vests, visors, anoraks, baseball caps, caps, hats, windshirts, blouses, shirts, golf shirts, polo shirts, knit shirts, sport shirts, jackets, wind resistant jackets, pullovers, pants, and slacks, all sold only to businesses and organizations for embellishment with the marks and logos of others" in International Class 25. This registration is incontestable pursuant to 15 U.S.C. § 1065 and thus constitutes conclusive evidence of

Opposer's exclusive rights for the PORT AUTHORITY mark for the recited goods. The current TSDR and Assignment records for Registration No. 2,787,770 are attached hereto as Exhibit 1 and made a part hereof by this reference.

7. Opposer owns U.S. Trademark Registration No. 2,690,708, issued on February 25, 2003, for the mark PORT AND COMPANY for "Blankets, namely, stadium blankets and travel blankets" in International Class 24 and "Clothing, namely shirts, sport shirts, t-shirts, sweatshirts, windshirts, vests, jackets, fleece jackets, anoraks, pullovers, nylon pants, visors, and caps" in International Class 25. This registration is incontestable pursuant to 15 U.S.C. § 1065 and thus constitutes conclusive evidence of Opposer's exclusive rights for the PORT AND COMPANY mark for the recited goods. The current TSDR and Assignment records for Registration No. 2,690,708 are attached hereto as Exhibit 2 and made a part hereof by this reference.

8. Opposer owns U.S. Trademark Registration No. 2,852,516, issued on June 15, 2004, for the mark PORT AUTHORITY SIGNATURE for "Clothing, namely, shirts, sport shirts, polo shirts, knit shirts, golf shirts, jacket, leather jackets, all sold only to business and organizations for embellishment with the marks and logos of others" in International Class 25. This registration is incontestable pursuant to 15 U.S.C. § 1065 and thus constitutes conclusive evidence of Opposer's exclusive rights for the PORT AUTHORITY SIGNATURE mark for the recited goods. The current TSDR and Assignment records for Registration No. 2,852,516 are attached hereto as Exhibit 3 and made a part hereof by this reference.

9. Opposer owns U.S. Trademark Registration No. 3,323,082, issued on October 30, 2007, for the mark PORTFLEX for "Headgear, namely, hats and caps" in International Class 25. This registration is incontestable pursuant to 15 U.S.C. § 1065 and thus constitutes conclusive evidence of Opposer's exclusive rights for the PORTFLEX mark for the recited goods. The

current TSDR and Assignment records for Registration No. 3,323,082 are attached hereto as Exhibit 4 and made a part hereof by this reference.

10. On October 8, 2015, Port Deluxe, LLC, a Massachusetts limited liability company, filed an application to register the mark PORT DELUXE for “Athletic footwear; Athletic pants; Athletic shirts; Athletic shoes; Athletic shorts; Athletic skirts; Athletic tights; Basketball sneakers; Bottoms; Coats; Footwear; Gym pants; Gym shorts; Gym suits; Jackets; Jerseys; Pants; Pocket kerchiefs; Shifts; Shirts and short-sleeved shirts; Shoes; Short-sleeved or long-sleeved t-shirts; Shorts; Sweatpants; Sweatshirts; Sweatsuits; T-shirts; Tank tops; Tights; Tops; Track jackets; Track pants; Track suits” in International Class 25, which was assigned Serial No. 86/781,795. The PORT DELUXE mark was published in the Official Gazette on April 12, 2016.

11. Prior to Applicant’s filing date of October 8, 2015, Opposer had been using its PORT AUTHORITY, PORT AND COMPANY, PORT AUTHORITY SIGNATURE, and PORTFLEX marks on clothing, bags, blankets, and headwear for years.

12. Opposer’s registrations for its PORT AUTHORITY, PORT AND COMPANY, PORT AUTHORITY SIGNATURE, and PORTFLEX marks have earlier filing dates and earlier priority dates than Applicant’s application for the mark PORT DELUXE; hence, Opposer’s registrations have priority over Applicant’s application.

13. The goods on which Applicant intends to use the mark PORT DELUXE, as evidenced by Applicant’s application, are identical or highly related to the goods on which Opposer uses its PORT AUTHORITY, PORT AND COMPANY, PORT AUTHORITY SIGNATURE, and PORTFLEX marks.

14. The mark PORT DELUXE, as evidenced by Applicant’s application, is very similar in sight, sound, and meaning to Opposer’s PORT AUTHORITY, PORT AND COMPANY, PORT AUTHORITY SIGNATURE, and PORTFLEX marks.

15. The similarity of the mark PORT DELUXE to Opposer's PORT AUTHORITY, PORT AND COMPANY, PORT AUTHORITY SIGNATURE, and PORTFLEX marks is compounded by the fact that "DELUXE" is a non-distinctive word.

16. The similarity of the mark PORT DELUXE to Opposer's PORT AUTHORITY, PORT AND COMPANY, PORT AUTHORITY SIGNATURE, and PORTFLEX marks is also compounded by the fact that Applicant has disclaimed the word "DELUXE" in its mark.

17. The mark PORT DELUXE, as evidenced by Applicant's application, so resembles each and all of Opposer's PORT AUTHORITY, PORT AND COMPANY, PORT AUTHORITY SIGNATURE, and PORTFLEX marks as to be likely to cause confusion, mistake, or deception, when used in connection with identical or highly related goods, within the meaning of Section 2(d) of the Lanham Trademark Act.

18. The mark PORT DELUXE, with "DELUXE" disclaimed, includes within it the identical distinctive word PORT as is in each and all of Opposer's PORT AUTHORITY, PORT AND COMPANY, PORT AUTHORITY SIGNATURE, and PORTFLEX marks, and as such, misleads consumers into believing the goods on which Applicant intends to use the PORT DELUXE mark are a portion, extension, expansion, or collaboration with Opposer's marks and products, or are otherwise associated with Opposer, when they are not.

19. The addition of the non-distinctive, disclaimed, and descriptive word DELUXE does not distinguish Applicant's Mark from Opposer's marks, and in fact makes confusion *more* likely because Applicant's goods appear to be a line of goods related to Opposer's goods.

20. Accordingly, Opposer will be damaged by the registration Applicant seeks because the registration will assist and support Applicant in the confusing and misleading use of the mark PORT DELUXE and will give color of exclusive statutory rights to Applicant in violation and derogation of Opposer's prior rights.


WHEREFORE, Opposer prays that the opposition be sustained and that registration to Applicant be refused.


