NOTICE OF OPPOSITION

BASSIKE PTY LTD (OPPOSER), a proprietary limited company of Australia, having a place of business at Studio 14, Daydream Street, Warriewood, NSW, Australia, 2102, believes that it is or will be damaged by the registration of the mark set forth in Application No. 86/883,226, which the United States Patent and Trademark Office (USPTO) records show is owned by JB INTERNATIONAL HOLDINGS LIMITED (Applicant), and hereby opposes the same.

To the best of OPPOSER's knowledge, the name and address of the current owner of the application is JB INTERNATIONAL HOLDINGS LIMITED, a limited liability company of Hong Kong, 6th Floor, St-John's Building, 33 Garden Road, Central, Hong Kong.

The grounds for opposition are as follows:

Likelihood of Confusion under Section 2(d) of the Trademark Act

1. OPPOSER is the owner of U.S. Trademark Registration No. 3,712,189, for the mark "BASSIKE" and design, which issued from application serial no. 79/057,566. Under Section 66(A) of the Madrid Protocol, this registration has priority to International Registration

No. 973,779, and is therefore entitled to a filing date of July 29, 2008. A combined Section 71 and 15 Declaration was filed on Nov. 2, 2015, and accepted by the U.S. Patent and Trademark Office on Dec. 11, 2015, making this registration incontestable. A printout from the USPTO TDSR database satisfying the requirements of 37 C.F.R. Section 2.122(d) for submitting a current status and title copy of the pleaded registration, is submitted herewith as Exhibit 1. As stated in the registration, "The term BASSIKE is pronounced as in the English word "basic" (*i.e.* bey-sik)". The registration recites the following goods:

Clothing, namely, t-shirts, tops, sweaters, sweat shirts, track pants, short sleeve and long sleeve shirts, singlets, tank tops, shorts, jeans, pants, dresses, suit jackets, casual jackets, scarves, vests headgear, namely, caps and hats in International Class 025.

2. OPPOSER is the owner of U.S. Trademark Registration No. 4,903,405, for the mark "BASSIKE", which issued from application serial no. 79/167,762. Under Section 66(A) of the Madrid Protocol, this registration has priority to International Registration No. 1,253,200, and is therefore entitled to a filing date of April 17, 2015. A printout from the USPTO TDSR database satisfying the requirements of 37 C.F.R. Section 2.122(d) for submitting a current status and title copy of the pleaded registration, is submitted herewith as Exhibit 2. The registration recites the following goods:

Sunglasses in International Class 009

Jewelry in International Class 014

Beach towels in International Class 024

Clothing, namely, shirts, pants, dresses, t-shirts, tops, bottoms, sweaters, sweat shirts, track pants, short sleeve and long sleeve shirts, singlets, tank tops, skirts, shorts, jeans, suit jackets, casual jackets, scarves, vests, polo tops, pullovers, hooded knitwear tops, fleece tops, cardigans, pyjamas, sleepwear,

loungewear, leggings, beachwear, swimwear, underwear, lingerie; headgear in the nature of hats, caps; footwear being shoes; children's clothing, namely, tops, bottoms, rompers, pajamas, dresses, leggings, swimwear, jeans, t-shirts, sweat shirts, track pants, short sleeve and long sleeve shirts, singlets, tank tops, skirts, shorts, pants, sweaters, cardigans, fleece tops, vests in International Class 025

3. OPPOSER is the owner of U.S. Trademark Registration No.4,907,748, for the mark "BASSIKE" and design, which issued from application serial no. 86/658,737, filed on July 11, 2015. A printout from the USPTO TDSR database satisfying the requirements of 37 C.F.R. Section 2.122(d) for submitting a current status and title copy of the pleaded registration, is submitted herewith as Exhibit 3. The registration recites the following goods:

Sunglasses in International Class 009

Jewelry in International Class 014

Beach towels in International Class 024

Shoes; apparel, namely, clothing in the nature of shirts, pants, dresses, t-shirts, tops, bottoms, sweaters, sweat shirts, track pants, short sleeve and long sleeve shirts, singlets, tank tops, skirts, shorts, jeans, pants, duplicate suit jackets, casual jackets, scarves, vests, polo tops, pullovers, hooded knitwear tops, fleece tops, cardigans, pyjamas, sleepwear, loungewear, leggings, beachwear, swimwear, underwear, lingerie; footwear, and headgear in the nature of hats, caps; children's clothing, namely, tops, bottoms, rompers, pajamas, dresses, leggings, swimwear, jeans, t-shirts, sweat shirts, track pants, short sleeve and long sleeve shirts, singlets, tank tops, skirts, shorts, duplicate pants, sweaters, cardigans, fleece tops, vests in International Class 025

Retail store and online retail store services featuring clothing, footwear, headgear and associated fashion accessories in International Class 035.

- 4. The three registrations described above, namely U.S. Reg. Nos. 3,712,189, 4,903,405, and 4,907,748, all owned by OPPOSER, are hereinafter referred to collectively as OPPOSER's Registrations.
- 5. On January 22, 2016, Applicant filed an application, serial no. 86/883,226 (the Subject Application), alleging a *bona fide* intent to use the mark "BASIK BY RD STYLE" in International Class 25 for the following goods, all of which are recited in one or more of OPPOSER's Registrations:

Women's clothing, namely, dresses, shirts, pants, skirts, shorts, halters, suits, blazers, dusters, jumpers, jackets, vests, tops, namely, hooded tops, sweat tops, tube tops, knitted and woven tops, T-shirts and robes, namely, bath robes, beach robes, and women's activewear, namely, jeans, jogging suits, sweat suits, bathing suits, lingerie, headwear, namely, hats and caps, gloves, scarves and outerwear, namely, coats and skiwear; men's activewear, namely, shirts, sweaters, pants, jeans, jogging suits, sweat suits, T-shirts, bathing suits and outerwear namely, jackets, coats and skiwear.

- 6. OPPOSER applied for "BASSIKE" well before Applicant began using or applied for "BASIK BY RD STYLE."
- 7. The Opposed Application comprises a mark that so resembles OPPOSER's mark "BASSIKE" as to be likely to cause confusion, or to cause mistake, or to deceive. OPPPOSER's mark "BASSIKE" and Applicant's mark "BASIK BY RD STYLE" are confusingly similar in appearance, sound, connotation, and overall commercial impression. Applicant's mark "BASIK BY RD STYLE" wholly incorporates a phonetically identical form of OPPOSER's mark "BASSIKE." Far from providing distinction between the marks, the phrase "BY RD STYLE" suggests some sort of affiliation between OPPOSER and Applicant,

who apparently operates under the brand name RD STYLE. The definite connotation that is given by Applicant's mark is that OPPOSER's brand is being produced or provided by RD STYLE. Applicant's combination of OPPOSER's mark with possessive phrase BY RD STYLE creates an overall commercial impression that creates a strong likelihood that the reasonable consumer will be confused into believing that there is some affiliation, sponsorship, or other relationship between OPPOSER and Applicant.

- 8. The goods, if not identical, are so closely related that the circumstances surrounding their marketing are such that they are likely to be encountered by the same persons under circumstances that, because of the marks used in connection therewith, would lead to the mistaken belief that they originate from the same source. The Subject Application is in International Class 025, the same class as OPPOSER's Registrations. The goods associated with the Subject Application, and the goods that are recited in OPPOSER's registrations are virtually identical, or at least significantly overlap. Given the similar marks and the virtually identical goods, there is a strong likelihood that consumers would be confused as to the source or sponsorship of the goods.
- 9. The channels of trade are not limited in the Opposed Application, and therefore it must be assumed that the channels of trade would include all possible channels. Therefore, it must be assumed that there would be significant overlap, if not shared identity, with OPPOSER's channels of trade. The very similar marks, being used on the same goods, in the same channels of trade, would lead to a strong likelihood of confusion in the marketplace.
- 10. OPPOSER has been using their mark in conjunction with the sale of clothing goods over the Internet, including selling and shipping products to the U.S., since well before

Applicant filed the Subject Application. OPPOSER'S mark has gained increasing recognition in the U.S., and in September 2015 OPPOSER opened a brick and mortar storefront in Venice Beach, California. The opening was publicized in various news sources, including The Hollywood Reporter. Together with OPPOSER's Registrations, which gives third-parties constructive notice of OPPOSER's ownership, this notoriety makes it highly likely that Applicant knew of OPPOSER and sought to capitalize on OPPOSER's notoriety and goodwill by adopting a confusingly similar mark.

WHEREFORE: OPPOSER opposes issuance of any registration based upon the Subject Application pursuant to Trademark Act Section 2(d), 15 U.S.C. 1052(d).
