MOTION TO CORRECT NAME OF SUBSTITUTED RESPONDENT

In accordance with TBMP Section 512, Respondent moves that its name be listed as Church & Dwight Company in this Cancellation Proceeding as Assignee from Enamelon, Inc. On January 7, 2002 the assignment of Registration No. 2,302,306 for "LIQUID CALCIUM" from Enamelon, Inc. to Church & Dwight Company was recorded with the Assignment Branch at Reel 002417 Frame 0299. Attached is a copy of the Notice of Recordation confirming this fact.

When Church & Dwight Co., Inc.¹ moved to reopen proceedings and substitute its name as Respondent, it was at that time the owner of the security interest in all assets of the original Respondent, Enamelon, Inc. As noted in "Respondent's Motion to Substitute Name of Respondent and Reopen Proceedings" filed on November 18, 2001, Church & Dwight Co., Inc., as owner of the security interest, assigned U.S. Registration Number 2,302,306 for "LIQUID CALCIUM" to Church & Dwight Company. By Order dated June 15, 2002, the Trademark Trial


and Appeal Board substituted "Church & Dwight Co., Inc.," as Respondent for the Cancellation proceeding herein. However, as shown in the attached Notice of Recordation from the Assignment Branch, the successor in interest to Enamelon, Inc. was Church & Dwight Company. Church & Dwight Co., Inc. was merely the owner of the security interest in assets of the former Respondent, Enamelon, Inc.

As a result, it is respectfully requested that the Trademark Trial and Appeal Board correct the name of Respondent and/or formally substitute Church & Dwight Company as respondent in this Cancellation proceeding and allow the proceeding to move forward with a caption reading Block Drug Company, Inc. v. Church & Dwight Company, (substituted as party defendant by assignment for Enamelon, Inc.).


