*Sakow v. 638 Seafood Restaurant Inc., et al., Index No. 606626/97*


*Matter of Sakow, Index No. 606627/97*

It is contemplated that the extensive discovery and the resolution of the issues in


the state court cases if not wholly dispositive of the issues in this matter, will contribute in some useful measure to a final determination of the issues raised in the Petition herein.




