Petitioner, Danilo'R., Inc., d/b/a/ Poleci, a California corporation having its principal place of business at 2221 East Washington Boulevard, Los Angeles, California 90021, believes that it is or will be damaged by Registration No. 2,290,214 and hereby petitions to cancel same.

As grounds for this petition, it is alleged that:

1. The Registrant has obtained a registration for THE ART OF DRESSING for clothing, namely, men's and women's shirts, pants, sweaters, jackets, coats, rain coats, suits, socks, shoes, hats, undergarments and sleepwear, claiming a first date of use 1997.
2. Petitioner has filed an Intent to Use application, Serial No. 78/211,417, to register the mark THE ART OF DRESSING for clothing.

3. Upon information and belief, Registrant is no longer using the mark THE ART OF DRESSING in connection with clothing, and its Trademark Registration No. 2,290,214 has been abandoned. Unless said registration is canceled, the registration may have an adverse impact on whether the Patent and Trademark Office will grant Petitioner's pending trademark application Serial No. 78/211,417 for THE ART OF DRESSING

4. Based on the foregoing, Registration No. 2,290,214 will cause injury and damage to the Petitioner.

WHEREFORE, Petitioner prays that Registration No. 2,290,214 be canceled and this Petition for Cancellation be sustained in favor of Petitioner.


