
**CONSENTED MOTION TO EXTEND DISCOVERY AND TESTIMONY PERIODS**

Applicant's counsel, Huiji Kim, consented to this request to extend discovery and




testimony periods as set forth above in the course of a telephone conversation with the undersigned on September 9, 2004.


