
Mr. Sir:

The United States Patent and Trademark Office, Trademark Trial and Appeal Board, graciously granted and extended a 90 day continuance in this matter in order for Conair Corporation and United States Identification Card to conclude an ongoing, amicable resolution and agreement in this matter and to cancel this action, or, for Registrant to either appoint new counsel or file a paper stating that respondent chooses to represent itself.

Due to several delays in this negotiation process, settlement agreement has not yet concluded whereby at this point we are awaiting the final draft of the final agreement from Mr. Richard A. Margulies of Conair Corporation, which he has stated by email will be provided this week due to his currently being out of town.

However, as we are very close to the culmination of the 90 day extension period for Registrant to respond, we have discussed this matter with another trademark attorney. He has suggested that since it appears we may conclude our agreement with Conair within the month of October 2005, we should file a written response to represent ourselves only until such time that these negotiations are not culminated timely whereby he will then file documents entering himself on record as attorney for the Registrant.

Hence, enclosed herewith please find our official notice and filing that Registrant chooses to represent itself. Should the settlement agreement be completed as expected, Conair Corporation will shortly be filing a Stipulation for Dismissal which they have already drawn up and provided to me for which we are now only awaiting the final agreement draft.



Dear Mr. Margulies:

Much time has lapsed since we commenced negotiations and since your initial draft of the proposed agreement in August 2005 for the transfer and assignment of our trademark name 'USA ID'. In this regard, because of your unexpected inclusion therein of additional agreement to also transfer and assign our primary trademark name 'USID / UNITED STATES IDENTIFICATION CARD', the finalization was delayed while renegotiation was concluded and we have since awaited the preparation and delivery of the final, revised covenant. It did not expedite matters that first I was out of town on business and upon my return you have yourself gone out of town.

It was concluded and agreed that the final agreement between ConAir and United States Identification Card, which you are to prepare and deliver, will consummate the immediate transfer and assignment of the trademark name 'USA ID' and will also include the transfer and assignment of the trademark name 'UNITED STATES IDENTIFICATION CARD / USID'. Further, the agreement will acknowledge and recognize the existence of present ongoing litigation pertaining to UNITED STATES IDENTIFICATION CARD / USID in the state of California whereby ConAir will irregardless proceed with its offer and conclude the transfer and assignment of UNITED STATES IDENTIFICATION CARD / USID. Further, without any reservations or restrictions whatsoever, we will retain full usage and rights to the use of the trademark name(s) UNITED STATES IDENTIFICATION CARD / USID until litigation is concluded and/or until the specified date of June 30, 2006.

I suggest that we complete this transaction on or before October 14, 2005. As you are aware, the U.S. Trademark Office accommodated our negotiations with a 90 day extension on July 21, 2005. With that in mind, I am compelled to provide written response to the U.S. Trademark Office on or before October 14th.
