

1 PLEASE TAKE NOTICE that petitioner Jzchak Wajcman respectfully objects to the
2 Request For Judicial Notice Of Patent Referring To Bill Lawrence As A Living Person filed by
3 respondent Willi Lorenz Stich on October 05, 2006 as being untimely.

5 37 CFR § 2.127(a) clearly states in part:

6 *The Board may, in its discretion, consider a reply brief. Except as*
7 *provided in paragraph (e)(1) of this section, a reply brief, if filed,*
8 *shall be filed within 15 days from the date of service of the brief*
9 *in response to the motion. The time for filing a reply brief will not*
10 *be extended.*

11 Moreover, 37 CFR § 2.127(e)(1) clearly states in part:

12 *[A] Brief in response to the motion for summary judgment shall be filed within*
13 *30 days from the date of service of the motion unless the time is extended by*
14 *stipulation of the parties approved by the Board, or upon motion granted by the*
15 *Board, or upon order of the Board.*


16 The above identified document was filed and served by respondent Willi Lorenz Stich on
17 October 05, 2006. If it can be construed as being in support of respondent Stich's motion for
18 summary judgment it is untimely because the date of service of the petitioner's brief in response
19 to the motion was August 18, 2006 and therefore all replies thereto were due on or before
20 September 04, 2006. If it can be construed as being in opposition to petitioner's motion for
21 summary judgment it is untimely because the date of service of the petitioner's motion for
22 summary judgment was August 18, 2006 and therefore all documents in opposition to the motion
23 were due on or before September 18, 2006. Clearly, both dates have long passed and
24 respondent's most recent filing is objected to and should be disregarded.

25 PLEASE TAKE FURTHER NOTICE that petitioner Jzchak Wajcman also respectfully
26 objects to respondent Stich's Request For Judicial Notice Of Patent Referring To Bill Lawrence
27 As A Living Person as being nonsensical. The respondent in these proceedings is Willi Lorenz
28 Stich. That is his legal name. There is no such person as Bill Lawrence. The name Bill Lawrence
is merely a trade name and trademark which is the exact subject of these proceedings. It is
improper for Respondent Stich to essentially request that the Board grant him a name change.

Moreover, his insistence on signing legal documents related to these proceedings as "Bill Lawrence" is both improper and ineffective since Bill Lawrence is a non-existent, fictitious person who is not a party to these proceedings. Petitioner Jzchak Wajcman respectfully requests that all such documents be totally disregarded by the Board.


