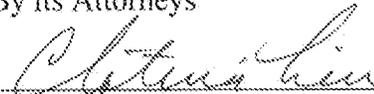
1. The civil action in San Diego Superior Court Case Number GIC875865 was dismissed on November 14, 2007.

2. The Parties agree that discovery shall be reopened for a period of One Hundred and Twenty Days (120) from the date the TTAB issues an order resuming this action.
3. The Defendant and Idol Writer LLC request that Idol Writer LLC be substituted as the Defendant in this action. It is Plaintiff's understanding that Britt Ventures Corp. merged into EDR Ventures, LLC ("EDR") on March 7, 2007, a copy of the Certificate of Merger is attached hereto as Exhibit A. Subsequently, EDR assigned the trademark IDOL WRITER to Phillip Elden, and Phillip Elden assigned the trademark IDOL WRITER to Idol Writer, LLC. It is also Plaintiff's understanding that Idol Writer, LLC will record the assignment of the IDOL WRITER trademark with the PTO. Subject to this understanding, Plaintiff does not oppose such substitution of parties.
4. This stipulation may be executed simultaneously in two or more counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument.

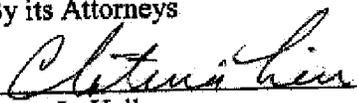

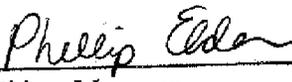
