PETITION FOR CANCELLATION

Le Tigre, LLC, a limited liability company organized and existing under the laws of the state of Delaware with a place of business at 152 Madison Avenue, New York, New York 10016 (hereinafter referred to as "Petitioner") believes that it is or will be damaged by Registration No. 859,437, and hereby petitions to cancel the same.

To the best of Petitioner's knowledge, the name and address of the current owner of Registration No. 859,437 is Chesebrough-Pond's Inc., with a place of business at 501 Silverside Road, Wilmington, Delaware 19809 (hereinafter referred to as "Respondent").

As grounds for cancellation, it is alleged that:

1. On August 11, 2004, Petitioner filed an intent-to-use application for registration of the trademark "LE TIGRE" and Design on the Principal Register of the United States Patent and Trademark Office (the "PTO"). This application covers "cosmetics, perfumes, skin care products; hair care products." This application has been designated as U.S.S.N. 78/465,877 in the records of the PTO.

2. On March 29, 2005, the PTO Examining Attorney issued an Office Action preliminarily refusing registration of Petitioner's trademark "LE TIGRE" and Design under Section 2(d) of the Trademark Act (15 U.S.C. Section 1052(d)), based upon Registration No. 859,437, issued on October 29, 1968 to Faberge, Inc., for the trademark "TIGER" covering "cologne, aftershave lotion, deodorant." Petitioner submits Registration No. 859,437 was later transferred by to Chesebrough-Pond's Inc. ("CPI") through a number of assignments and mergers.

3. On information and belief, CPI has abandoned its trademark "TIGER", as evidenced, for example, by non-use of this trademark.

4. Petitioner is being injured by the continued presence on the Principal Register of Registration No. 859,437 for the trademark "TIGER," because this trademark (which, on information and belief, has been abandoned) continues to act as an obstacle to the registration of Petitioner's trademark "LE TIGRE" and Design on the Principal Register.

WHEREFORE, for the above reasons, New England respectfully prays that Registration No. 859,437 for "LE TIGRE" and Design be cancelled.

WHEREFORE, Petitioner prays that Registration No. 859,437 be canceled and that this Petition for Cancellation be sustained in favor of Petitioner.
