MOTION TO AMEND REGISTRATION

Pursuant to a Settlement Agreement entered into by the Parties (“Agreement”), Registrant Kerzner International Resorts, Inc. (“Kerzner”) hereby moves to amend Registration No. 2810825 (the “Registration”). Kerzner requests that the Board delete “casino facilities,” “nightclubs,” “bars,” and “casinos” from the services listed in International Class 41 and delete all services listed in International Class 42. The amended registration should cover only “Providing entertainment in the nature of live musical and dance performance” in International Class 41 and no services in International Class 42. As shown by its counsel’s signature below, Opposer Monarch Casino & Resort, Inc. has consented to this amendment.

Pursuant to the terms of the Agreement, once the Board amends the Registration, Monarch will withdraw its cancellation petition against the Registration with prejudice. Kerzner requests that all deadlines remain suspended while this Motion is under consideration.
