the parties settlement negotiations. Since that time, the parties have exchanged further offers and counter-offers for settlement and resolution of this matter. The most recent offer was provided by Petitioner and taken under consideration by Respondent on November 15, 2007. At that time, counsel for Petitioner requested a further extension of time to the discovery deadlines so that the parties could continue negotiations. Counsel for respondent indicated that she would confer with her client to see if Respondent would stipulate to a further extension of discovery cut-off. Petitioner has not received a response to her pending offer or the request for a stipulated extension of time. Accordingly, Petitioner hereby moves for a further 30 day extension of time to allow the parties to continue their settlement negotiations, including obtaining a considered response from Respondent to her current settlement offer.


