PETITION FOR CANCELLATION

Petitioner, Nicole Linkon, a United States citizen, doing business at 10 Peninsula, Newport Beach, California 92657, believes that it is or will be damaged by Registration No. 3,028,542, and hereby petitions to cancel same.

Upon information and belief, Respondent, Style International Source, LLC is a California corporation, having a business address at 5120 West 190th Street Unit 219, Torrance, California 90503.

Description of Respondent's registration: Filed on October 22, 2004, for the mark CHERRY B Stylized, registered on the Principal Register in Class 25 for "clothing, namely, jeans, shirts, pants, dresses, skirts, t-shirts, sleepwear, coats, sweaters, shoes, footwear, hats, headbands, sweatpants, sweatshirts," claiming first use in 2004.

As grounds for this Petition, it is alleged that:

1. Respondent has abandoned said registered mark by discontinuing its use with no intent to resume said use. Petitioner will be impaired by the continued registration of said abandoned mark of Respondent, since its continued existence on the Principal Register will prevent Petitioner from registering its mark.

WHEREFORE, Petitioner prays that Registration No. 3,028,542 be canceled, and that this Petition for Cancellation be sustained in favor of Petitioner.
