**DECLARATION OF DAVID A. LOWE IN SUPPORT OF REGISTRANT'S
OPPOSITION TO MOTION TO AMEND PLEADING**

I, David A. Lowe, hereby declare as follows.

1. I am counsel of record for Aimbridge Lending Group, LLC, the successor interest to Registrant The Aimbridge Group, in this cancellation proceeding. I have personal knowledge of the facts set forth in this declaration.

2. Attached as Exhibit 1 is a true and correct copy of the specimen submitted by Petitioner East West Bank ("EWB") in association with its application to register the purported mark YOUR FINANCIAL BRIDGE, application serial number 78/897,563. The specimen includes dates indicating that it was created sometime in 2005. I am not aware of the existence of any specimens for YOUR FINANCIAL BRIDGE that were in existence at an earlier time, including any purported specimens that would include an image of a bridge forming a part of the mark as alleged in the proposed amended pleading submitted by EWB.

3. Attached as Exhibit 2 are true and accurate copies of EWB website webpages (www.eastwestbank.com) I obtained from the Internet as well as the archive website WayBackMachine (www.archive.org). These webpages demonstrate present and historical website use by EWB. The webpages are dated along the bottom of the pages with the current

date when I obtained the webpages as well as the date the original webpages were archived by the WayBackMachine website.

4. Attached as Exhibit 3 is a true and correct copy of the specimen submitted by East West Bank in association for its application to register the purported mark BUSINESS BRIDGE, application serial number 78/890,654. The specimen is undated but appears to have been first used sometime in 2005. The specimen does not include an image of a bridge anywhere, and certainly not accompanying the term BUSINESS BRIDGE.

5. There are numerous third parties in the financial industry who hold current active registrations for marks that include the term BRIDGE as a part of the mark. Attached as Exhibit 4 are true and correct copies of the Certificates of Registration I obtained on September 11, 2007 from the USPTO website for the seventy marks owned by third parties that incorporate the term BRIDGE and are for goods or services related to financial, bank or banking.

6. Attached as Exhibit 5 are true and accurate copies of website webpages I obtained from the Internet as well as the archive website WayBackMachine (www.archive.org). This archive site has captured and archived websites since 1996. These webpages demonstrate present and historical use by third parties of marks incorporating the BRIDGE term for a wide variety of financial services. The webpages are dated along the bottom of the pages with the current date when I obtained the webpages as well as the date the original webpages were archived by the WayBackMachine website.

I declare under penalty of perjury under the laws of the United States of America that the foregoing is true and correct.
