PETITION FOR CANCELLATION

Chr. Hansen A/S, a Denmark corporation with a principal place of business at Boege Allé 10-12 DK-2970 Hoersholm, Denmark ("Petitioner"), believes that it will be damaged by the continued registration of U.S. Registration No. 2524033 and hereby petitions to cancel same. As grounds of cancellation, it is alleged that:

1. Upon information and belief, the Registrant Lesaffre & Cie (hereinafter "Registrant"), a France limited liability partnership with a principal place of business at 41, Rue Etienne Marcel, 75001 Paris, France.
2. Registrant filed an application to register the mark SAF PRO in the United States Patent and Trademark Office on September 9, 1999. This application was accorded Serial Number 75794844.
3. Registrant's application Serial Number 75794844 issued into Registration No. 2524033 on January 1, 2002 for "ingredients and additives for industrial and commercial use

in preparing and improving bread, namely, dough conditioners, primary leaven yeast, leaven barm and alimentary pastes, sour dough flavoring and sour dough starter culture; aromatic chemicals for use in the manufacture of food” in International Class 1; and for “flour; bread; pastries; confectionery chips for baking; honey; treacle; yeast; baking powder; leaven; primary leaven; salt; aromatic food additives for non-nutritional purposes” in International Class 30.

4. Petitioner is the owner of pending U.S. Trademark Application Serial No. 79/013650 for SAFEPRO for “bacteriological preparations for use in scientific research and food manufacture and not for medical and veterinary applications; enzyme preparations for industrial use” in International Class 1; “food colorants, including natural colorants” in International Class 2; “enzyme preparations for medical and veterinary use; bacteriological preparations for medical and veterinary use” in International Class 5; “milk and milk products excluding ice cream, ice milk, and frozen yoghurt; edible oils and fats; prepared foods, namely meat” in International Class 29; and for “spices; seasonings; spices and aromatic substances for food in the nature of preparation for food, namely food additives for non-nutritional purposes for use as a flavouring; food flavourings, other than essential oils” in International Class 30.

5. The Examining Attorney has cited U.S. Reg. No. 2524033 as a bar to registration of Petitioner’s application, Serial No. 79/013650. As such, Petitioner has standing to bring this action.

6. Upon information and belief, Registrant is not using its mark SAF PRO in United States commerce.

7. Upon information and belief, Registrant has abandoned its mark SAF PRO in the United States.

WHEREFORE, Petitioner prays that U.S. Reg. No. 2524033 be cancelled, and this Cancellation Proceeding be sustained in Petitioner's favor.
