MOTION FOR SUSPENSION FOR SETTLEMENT WITH CONSENT

Respondent Universal Cooperatives, Inc. (“Respondent”), with the consent of Petitioner Jorge Enrique Vera Vargas (“Petitioner”), hereby moves to suspend and seeks an order suspending this matter and extending all deadlines in this matter as set forth below.

The parties are actively engaged in negotiations for the settlement of this matter. Universal Cooperatives, Inc. requests that this proceeding be suspended for 180 days to allow the parties to continue their settlement efforts.

As noted, Respondent has secured the express consent of the Petitioner in this proceeding for the suspension requested herein. The parties have entered into preliminary settlement discussions, and the requested extensions are necessary to allow the parties to continue such discussions rather than immediately focus on discovery matters. The extensions are not sought for purposes of delay.


