Description of registrant's registration: Filed on June 27, 1989 for the mark 24 HORAS in typed form, registered on the Principal Register, in International Class 041, for "ENTERTAINMENT SERVICES IN THE NATURE OF PRESENTATION OF A TELEVISION NEWS PROGRAM," claiming first use on September 13, 1976.

Current owner of registration: To the best of petitioner's knowledge and belief, the current owner of the above-identified registration is TELEVISA S.A. DE C.V., whose address is 2 Piso Rio Riber 85, Mexico City 06500.

As grounds for this petition, it is alleged that:

1. Petitioner provides "newspaper and magazines" under the mark 24 HORAS USA in typed form.

2. Petitioner was the applicant of U.S. trademark application Serial No. 76/668,320, filed October 30, 2006, for the mark 24 HORAS USA in typed form for "newspapers and magazines."

3. The aforementioned application Serial No. 76/668,320 for the mark 24 HORAS USA in typed form, by petitioner, has been refused as likely to cause confusion, or to cause mistake, or to deceive, in view of registrant's aforementioned registration No. 1,585,119.

4. Upon information and belief, registrant has abandoned said registered mark by discontinuing use of said mark with no intent to resume said use.

5. Petitioner is likely to be damaged by continuance on the register of said Registration No. 1,585,119 as petitioner presently intends to use the mark 24 HORAS USA in typed form for "newspapers and magazines," and petitioner's ability to obtain its own registration of this mark is being impaired and the continuance of petitioner's legal use of said mark will be impaired by the continued registration of said abandoned mark of registrant.


POWER OF ATTORNEY


