**PETITION TO CANCEL**

RideVehicles LLC, a California Limited Liability Company, with a principal address of 3991 Camino Ranchero, Camarillo, California 93012 is the Petitioner in this cancellation proceeding.

To the best of Petitioner's knowledge, the name and address of the current owner of Registration No. 2,588,325 is Electric Ride, Inc., with a principal address of 2029 No. Ocean Boulevard, #307, Ft. Lauderdale, Florida 33305.

The above-identified Petitioner believes that it will be damaged by the above-identified registration, and hereby petitions to cancel the same.

The grounds for cancellation are as follows:

1. On April 24, 2007, Petitioner filed trademark application Serial No. 77/164,223 in the United States Patent and Trademark Office for the mark RIDE and Design for "motorized, electric-powered, self-propelled self-balancing, wheeled personal mobility transportation 2588325 Device; Cars, Motorcycles; Motorized Scooters". The application claimed a date of first use of the RIDE and Design mark in connection with the above-identified goods of January 24, 2007.

2. On August 7, 2007, an Office Action issued on trademark application Serial No.

300.60 UP

77/164,223. Registration of Petitioner's proposed mark RIDE and Design was being refused because of an alleged likelihood of confusion with the mark in Registration No. 2,588,325. Registration No. 2,588,325 for ELECTRIC RIDE and Design issued on July 2, 2002 to Electric Ride, Inc. for "electric bicycles, electric tricycles, and electric wheel chairs".

3. Electric Ride, Inc., owner and registrant of the ELECTRIC RIDE and Design mark is no longer doing or conducting business, having been voluntarily dissolved on May 24, 2004. It has therefore neither sold nor distributed its products or goods under its registered trademark since at least May 24, 2004.

4. Attached hereto as Exhibit A is a printout from the Florida Department of State Division of Corporations evidencing the voluntary dissolution of Electric Ride, Inc. on May 24, 2004. Registrant's status is stated to be "inactive", which effectively means that registrant is not using the ELECTRIC RIDE and design mark in commerce in connection with the sale of "electric bicycles, electric tricycles and electric wheel chairs".


5. Trademark law provides for cancelling a registration "[a]t any time if the registered mark..... has been abandoned." 15 U.S.C. Section 1064(3)(1994) and defines abandonment as discontinued use with an intent not to resume. Exhibit A provides prima facie evidence of abandonment of the ELECTRIC RIDE and Design mark by registrant.

6. RideVehicles, LLC therefore petitions the Trademark Trial and Appeal Board to cancel Registration No. 2,588,325 pursuant to Section 1064(3)(1994).
