MOTION FOR EXTENSION OF TIME TO ANSWER PETITION

Registrant, Michael Marryshow¹, by and through its undersigned attorneys, K&L Gates, respectfully requests a thirty (30) day extension to answer Petitioner's Petition to Cancel Registrant's Registration No. 3,206,010.

Petitioner, Gordo Enterprises, Inc., filed the present Petition on or about March 22, 2008. It appears that the Notice and Trial Dates were sent by the Board to Registrant on or about March 26, 2008. It is unclear whether the Notice and Trial Dates were ever received by Mr. Marryshow, as the U.S. PTO Board records indicate that this document was returned to the U.S. PTO Board undelivered. Registrant only engaged the below-signed attorney and confirmed the filing of the above documents on or about May 2, 2008.

In light of the uncertainty of the delivery of the Notice and Trial Dates and the late date upon which Registrant was able to obtain representation, Registrant requires a thirty (30) day extension to file an Answer in order to evaluate his options with the below-signed attorney and to properly prepare an Answer. Neither the Applicant nor the below-signed attorney has contacted the Petitioner with regard to this Petition or this Request for Extension of Time due to the lack of time.

WHEREFORE, Registrant Michael Marryshow prays that the Board grant this thirty (30) day extension of time to file an Answer and re-set the schedule of discovery and trial dates accordingly.
