

2. Registration Serial No. 3,328,133 (ROHAN & design), amended to **R.O.H.A.N** & design.


Registrant submits that these alterations are not material as required by TMEP §1609.02(a). Here, the addition of periods between the individual letters of the word and design marks do not materially alter the marks because the marks still contain the exact same letters in the exact same sequence. Thus, the marks as amended contain the essence of the original marks and create essentially the same impression as the original mark. *See In re Umax Data Systems, Inc.*, 40 U.S.P.Q.2d 1539 (Comm'r Pats. 1996).
