**PETITIONER'S REQUEST FOR 270 DAY EXTENSION OF ALL DEADLINES
WITH CONSENT**

Petitioner, Michael J. Peter, ("Petitioner"), by and through the undersigned counsel, hereby requests an extension of all deadlines for an additional 270 days or nine months, with Consent of Registrant.

Since the last extension requests, the Parties have had discussions and have come to agreement on additional areas in the agreement that were previously being negotiated.

Registrant provided Petitioner with an updated proposed agreement, which contained language, for the first time, involving other pending applications of the Registrant. Petitioner forwarded revisions to the updated proposed agreement revising the scope of the newly added language and making certain obligations and consents reciprocal.

The requested 270 day extension is being requested in view of the possibility of additional back and forth negotiations and to allow sufficient time for Petitioner to present the final Co-Existence Agreement to the Examining Attorney who has cited Registrant's registration against Petitioner's pending/suspended SG application.

WHEREFORE, Petitioner respectfully requests that the Board grant this Request for Deadline Extension, thus, revising the remaining deadlines as indicated above.
