PETITION FOR CANCELLATION

Cancellation No. _____

Emerson Electric Co. ("Petitioner"), by and through its attorneys, hereby submits its Petition for Cancellation of U.S. Trademark Registration Nos. 1,119,176 and 1,612,846 for the mark EMERSON QUIET KOOL in Class 11 owned by Airwell Hong Kong Technologies Limited ("Airwell"). Petitioner believes it is damaged and will continue to be damaged by these registrations, and hereby petitions for their cancellation pursuant to 15 U.S.C. §§ 1067 and 1068.

Description of Owner's Registrations:

No. 1,119,176 for the mark EMERSON QUIET KOOL for "air conditioning units" in International Class 11; and

No. 1,612,846 for the mark EMERSON QUIET KOOL for “dehumidifiers” in International Class 11.

As grounds in support of its petition for cancellation, Petitioner asserts as follows:

1. Petitioner is a corporation duly organized and existing under the laws of the State of Missouri, with a principal place of business at 8000 West Florissant Avenue, St. Louis, Missouri 63136.

2. Upon information and belief, Airwell is a corporation duly organized and existing under the laws of Hong Kong, with a principal place of business at 1401 Hutchison House, 10 Harcour, Hong Kong, Hong Kong.

3. Petitioner is a diversified global manufacturing and technology company offering a wide range of products and services in the areas of process management, climate technologies, network power, storage solutions, professional tools, appliance solutions, motor technologies, and industrial automation. Petitioner is widely known for its engineering capabilities and management excellence, with more than 140,000 employees and approximately 265 manufacturing locations worldwide.

4. Petitioner is the owner of record of the following relevant U.S. Trademark Applications:

Serial No. 76/975,789 filed on October 13, 2000 for the mark EMERSON & Design (Double Helix) for “humidifiers” in International Class 11 (the “789 application”);

Serial No. 76/978,210 filed on October 13, 2000 for the mark EMERSON & Design (Double Helix) for “household air cleaners; air purifying units for domestic, commercial and industrial use; ventilating fans and blowers for commercial, industrial and agricultural use; ceiling fans; air circulators” (the “210 application”); and

Serial No. 76/294,524 filed on August 6, 2001 for the mark EMERSON PROCESS MANAGEMENT for a variety of goods and services in International Classes 9, 37 and 42 (the "524 application")

("Petitioner's Applications"). Copies of the TARR Printouts of Petitioner's Applications are attached hereto as Exhibit A.

5. Airwell is the owner of record of the following U.S. Trademark Registrations for which cancellation is requested:

No. 1,119,176 for the mark EMERSON QUIET KOOL for "air conditioning units" in International Class 11; and

No. 1,612,846 for the mark EMERSON QUIET KOOL for "dehumidifiers" in International Class 11

(the "Airwell registrations"). Copies of certificates of registration, current TARR printouts and Trademark Assignment Abstracts of Title for the Airwell registrations are attached as Exhibit B.

6. On February 13, 2007, the United States Patent and Trademark Office ("USPTO") denied Petitioner's Request for Reconsideration and maintained its final refusal to register the '789 Application, contending that Petitioner's EMERSON & Design (Double Helix) mark is confusingly similar to the marks covered by the Airwell registrations.

7. On May 20, 2007, the USPTO denied petitioner's Request for Reconsideration and maintained its final refusal to register the '210 Application, contending that Petitioner's EMERSON & Design (Double Helix) mark is confusingly similar to the marks covered by the Airwell registrations.

8. On July 30, 2007, the USPTO denied petitioner's Request for Reconsideration and maintained its final refusal to register the '524 Application, contending that Petitioner's EMERSON PROCESS MANAGEMENT mark is confusingly similar to the marks covered by the Airwell registrations.

9. Upon information and belief, Airwell has abandoned said registered marks by discontinuing use thereof with intent not to resume use.

10. Petitioner believes that it is and is likely to continue being damaged by the continued registration of the Airwell registrations sought to be canceled.

WHEREFORE, Petitioner prays Airwell's U.S. Trademark Registration Nos. 1,119,176 and 1,612,846 for the mark EMERSON QUIET KOOL in Class 11 be canceled, and that this Petition for Cancellation be sustained in favor of Petitioner.
