PETITION FOR CANCELLATION

Shelby Group International ("Petitioner"), a Tennessee corporation, located at 5321 E. Shelby Drive, Memphis, Tennessee, 38118, believes that it is being damaged by U.S. Trademark Registration No. 3306530 and U.S. Trademark Registration No. 3306533 (collectively "Registrations") and hereby petitions to cancel the same.

To the best of Petitioner's knowledge, the names and address of the current owner of the Registrations is Barbwire, LLC (hereinafter referred to as "Registrant"), a limited liability company of Arizona, whose last known address is 8711 E. Pinnacle Road, Scottsdale, Arizona 85255.

As grounds for this Petition, it is alleged that:

Registrant owns U.S. Registration No. 3306530 for BARBWIRE WESTERN
COUTURE (and design) for "retail apparel store" in International Class 35
("registered goods").

- Registrant owns U.S. Registration No. 3306533 for BARBWIRE WESTERN
 COUTURE for "retail apparel store" in International Class 35 ("registered goods").
- 3. Upon information and belief, use by Registrant of the marks BARBWIRE WESTERN COUTURE and BARBWIRE WESTERN COUTURE (and design) on the registered goods in the United States and/or in commerce within the United States has been discontinued with intent not to resume such use.
- 4. On August 5, 2008, Petitioner filed U.S. Application Serial Number 77/538,921 with the United States Patent and Trademark Office as an intent to use trademark application under § 1(b) for the mark BARBWIRE for "eyewear" in International Class 09.
- 5. In an Office Action dated March 30, 2009, the Trademark Office refused Petitioner's Application for the mark BARBWIRE on the basis of likelihood of confusion with Registrant's Registrations for the marks BARBWIRE WESTERN COUTURE (and design). As a result, Petitioner seeks to cancel Registrant's Registrations so that Petitioner's Application for its mark BARBWIRE will be allowed and the examiner's refusal withdrawn.
