PETITION TO CANCEL

Petitioner, Toastmasters International, Inc., is a California non-profit, public benefit corporation, with its principal place of business at 23182 Arroyo Vista, Rancho Santa Margarita, CA 92688 ("Petitioner" and "Toastmasters").

To the best of Petitioner's knowledge, the name and address of current owner of the registration is: Cristy Clarke, 66 Martha Road, Orinda, CA 94563 ("Respondent").

Petitioner, Toastmasters International, Inc., believes that it has been and will continue to be damaged by the above-identified registration for the mark TABLETOPICS, and hereby petitions to cancel the same.

The grounds for cancellation are as follows:

I. FACTUAL BACKGROUND

1. Since 1924, Toastmasters International has grown to become the world leader in helping people become more competent and comfortable in front of an audience, be it a planned presentation, a social situation, or impromptu conversation.

2. As a non-profit organization, Toastmasters is dedicated to the single public benefit of increasing the ability of others to communicate more clearly and effectively. Whether delivering a rousing and heartfelt wedding toast, presenting a business idea, or creating a warm environment for a eulogy, Toastmasters believes effective communication is the cornerstone to creating community.

3. Over its history, Toastmasters has helped millions of its members become more proficient speakers, and helped many more become increasingly comfortable speaking in group settings. While its own motivation is not profits, its members includes some of the most successful business leaders in the world, including, **Peter Coors** of Coors Brewing Company; **Debbi Fields**, founder of Mrs. Fields Cookies; **Tom Peters**, management expert and author; and **Linda Lingle**, Governor of Hawaii, to name a few.

4. Toastmasters' worldwide reach is unprecedented, having over 12,500 clubs in 106 countries, approximately 250,000 members worldwide, including 7,810 clubs in the United States. Since its inception, Toastmasters has had over 4 million members.

5. As a result of its dedication to excellence, and without a large marketing public relations budget, Toastmasters has been the subject of thousands of unsolicited articles, fan websites, and print media, all highlighting Toastmasters' innovative and successful techniques and products, including its public speaking tips, its

SPEECHCRAFT education seminar, and its TABLE TOPICS exercises, competitions, events and game.

6. Since at least as early as 1934, TABLE TOPICS activities have been part of every Toastmasters meeting.

7. A longstanding tradition that each member speak at a Toastmasters meeting gave rise to the TABLE TOPICS component.

8. A TABLE TOPICS event, exercise, game, or competition begins when a "Topicmaster" calls on a member to give an impromptu speech about a single topic. A TABLE TOPICS competition or game may also begin by drawing a TABLE TOPICS card which contains a single question. In both cases, the players are asked to speak impromptu, about the topic posed.

9. The TABLE TOPICS mark ("Petitioner's Mark") has been used continuously in connection with the call-and-response activity since at least as early as the 1950's, and the TABLE TOPICS card game has been used since at least as early as 1988. The mark is ubiquitous throughout the Toastmasters website.

10. The TABLE TOPICS game is also marketed to members and to the general public as a deck of cards game, which has been produced since at least as early as 1988. Petitioner has sold thousands of copies of its TABLE TOPICS game and over 18,000 copies of its TABLE TOPICS handouts. (Copies of the Petitioner's TABLE TOPICS game cards and other TABLE TOPICS products are attached hereto as Exhibit A)

11. In addition to being used on or in connection with a meeting game and card game, Petitioner uses the TABLE TOPICS mark on or in connection with a wide

variety of ancillary products, including trophies, contest guides and ballots, training programs, award certificates, ribbons and evaluation forms.

12. The TABLE TOPICS game and exercise is so closely associated with the Toastmasters brand that TABLE TOPICS has pervasive national prominence and an unprecedented degree of consumer recognition.

13. On or around November 13, 2003, Respondent filed with the United States Patent and Trademark Office (“PTO”) a use-based application for registration of the mark TABLETOPICS in connection with “game, namely a parlor game with question cards,” in International Class 28, alleging first use date in commerce on November 3, 2003. A true and correct copy of Respondent’s application for TABLETOPICS is attached hereto and incorporated herein as Exhibit B (the “Application”).

14. On or around December 21, 2004, Respondent obtained U.S. Trademark Registration No. 2,913,122 on the Principal Register for TABLETOPICS (the “Registration”). A true and correct copy of the Trademark Application and Registration Retrieval (“TARR”) status page for Registration No. 2,913,122 is attached as Exhibit C.

II. FIRST GROUND FOR CANCELLATION: PRIORITY OF USE

15. Petitioner incorporates by references paragraphs 1 through 14, as if fully set forth here.

16. Petitioner has priority of use for the composite mark TABLE TOPICS (“Petitioner’s Mark”) in connection with goods and services related to Respondent’s goods.

17. Petitioner has been using the mark TABLE TOPICS in commerce since at least as early as the 1950's.

18. Upon information and belief, Respondent did not start using the mark TABLETOPICS in connection with its parlor game with question cards until decades after Petitioner started using its mark TABLE TOPICS in connection with its related goods and services.

19. Petitioner has continuously used "TABLE TOPICS" in connection with its speaking exercises since 1934.

20. Petitioner's Mark symbolizes extensive good will and consumer recognition built by Petitioner through substantial amounts of time and efforts in advertising and promotion.

21. Respondent's registered mark TABLETOPICS is identical with Petitioner's mark TABLE TOPICS.

22. The parties' goods and/or services are identical and/or related.

23. Petitioner believes that, under section 2(d) of the Lanham Act, the Registration should be cancelled because Petitioner's Mark has prior use of its mark and Respondent's mark is confusingly similar to Respondent's mark.

III. SECOND GROUND FOR OPPOSITION: FALSE SUGGESTION OF A CONNECTION WITH AN INSTITUTION (Lanham Act §2(a))

24. Petitioner incorporates by references paragraphs 1 through 23, as if fully set forth here.

25. Toastmasters is the name of an "institution" within the meaning of Section 2(a) of the United States Trademark Act, 15 U.S.C. § § 1052(a), which prohibits the

registration of a mark that consists of or comprises matter which may falsely suggest a connection with, inter alia, institutions.

26. Respondent's TABLETOPICS registration is identical to the mark TABLE TOPICS, which is ingrained in the minds of consumers as being part of the Toastmasters curriculum; thus, the public would recognize it as identical to the name TABLE TOPICS and part of the Toastmasters program.

27. Toastmasters and its TABLE TOPICS game is not affiliated or connected at any level with Registrant or its TABLETOPICS goods, which are identical in every material respect to Toastmasters' TABLE TOPICS.

28. The fame and reputation of Toastmasters is such that, when Respondent's mark is used with Respondent's goods, a false connection with Toastmasters would be presumed.

IV. THIRD GROUND FOR CANCELLATION: LIKELIHOOD OF CONFUSION (Lanham Act §2(d))

29. Applicant incorporates by references paragraphs 1 through 28, inclusive, as if fully set forth here.

30. Applicant pleads in the alternative that the mark Respondent has registered, TABLETOPICS, is likely to cause confusion with Petitioner's TABLE TOPICS product, since the mark is fully incorporated into Petitioner's Mark.

31. The TABLETOPICS card decks offered by Respondent are nearly identical to Petitioner's TABLE TOPICS card decks. Both decks of cards are similar in overall packaging, design and overall appearance. Both decks of cards contain topic

discussions on printed cards, sold as a unit. Photographs demonstrating the similarities between Petitioner's goods and Respondent's goods are attached as Exhibit D.

32. Respondent's mark with injure Petitioner by causing potential and existing consumers to be confused or mistaken into believing that the goods sold by Respondent under the words "TABLETOPICS" are endorsed or sponsored by the goods sold by Petitioner under the TABLE TOPICS mark.

33. Respondent's registration will further damage Petitioner because Respondent's mark is likely, when used on or in connection with the goods described in its registration, to cause confusion, or to cause mistake or to deceive. Accordingly, pursuant to Sections 2(a), 2(d) and 3 of the United States Trademark Act, as amended, 15, U.S.C. 1052(d) and 1053, and should be refused registration.

34. Because of the shared channels of trade Petitioner and Respondent sell their goods, a greater likelihood of confusion would exist for potential consumers. In addition to Petitioner's distribution of its TABLE TOPICS cards and related products through its clubs, Petitioner also sells its TABLE TOPICS cards and other TABLE TOPICS products online via it's online storefront.

35. The fame and reputation of Toastmasters is such that, when Respondent's mark is used with Respondent's goods, a false connection with Toastmasters would be presumed.


WHEREFORE, Applicant prays that Registration No. 2,913,122 be cancelled.
