In that civil action, Case No. BC 430809 in the Superior Court of the State of California, County of Los Angeles (the "Civil Action"), discovery is ongoing. In addition, registrant herein has made a motion for summary judgment in the Civil Action, and the motion is scheduled to be heard on January 31, 2012. Trial in the Civil Action is scheduled to begin on May 29, 2012. Also, four defendants in the Civil Action who are not involved in this cancellation proceeding were dismissed from the Civil Action by the court earlier this year. Petitioner herein is in the process of appealing those dismissals.
