**MOTION TO CONSOLIDATE WITH CONSENT**

Pursuant to Fed. R. Civ. P. 42(a) and Trademark Board Manual of Procedure § 511, Respondent Dassa Holdings Ltd., with Petitioner's consent, moves the Board to consolidate Cancellation Proceedings Nos. 92052048 and 92052049.

Both cancellation proceedings were brought by the Petitioner, Silk Water Solutions Inc., against the single Respondent, Dassa Holdings Ltd. Thus there is identity of the parties. *See Bigfoot 4x4 Inc. v. Bear Foot Inc.*, 5 U.S.P.Q.2d 1444 (T.T.A.B. 1987). The proceedings involve common issues of law and fact.
