REQUEST FOR CORRECTION OF DATES

Univision Communications Inc. hereby requests the Board to reconsider the dates set forth in the Board’s order of July 28, 2014 (“July Order”). In the July Order, the Board grants Unimundo’s request for a 60 day extension. However, the dates set out on pages 3 – 4 of the July Order do not afford the extension granted in the July Order.

The July Order seeks to grant Unimundo a 60 day extension to the dates set out in the Board’s January 31, 2013 order. However, on December 6, 2013, the Board issued an order suspending this action pending the outcome of the Board’s decision on Univision’s motion to consolidate (see last page of Document 27 of the docket). The Board only issued its order on Univision’s motion to consolidate as part of its July Order and thus, according to the Board’s December 6, 2013 Order, this action and all dates related thereto were suspended from December 6, 2013 through July 28, 2014. Accordingly, for the Board to grant Unimundo a 60 day extension, all the dates set forth in the Board’s January 31, 2013 should be extended 60 days from the original time line, including initial disclosures, discovery deadlines, etc.

Counsel respectfully believes that the dates the Board intended to identify the dates below in its most recent July Order. These dates are calculated based on the time periods

afforded for each period in the Board's January 31, 2013 order plus 60 days as stated in the Board's July Order.
