**WOHALI OUTDOORS, LLC’S UNOPPOSED MOTION AND  
BRIEF IN SUPPORT FOR EXPEDITED CONSIDERATION  
OF WOHALI’S MOTION TO SUSPEND (FILED 11/1/13)**

Respondent/Defendant, Wohali Outdoors, LLC (“Wohali”), respectfully moves the Court to expedite its ruling on Respondent’s Motion to Suspend Proceedings Pending the Outcome of a Civil Action (“Wohali’s Motion to Suspend”) filed November 1, 2013. In support, Wohali submits the following.

1. Wohali’s Trial Period ends November 29, 2013. Currently, the deposition of J.T. Griffin is set for Tuesday, November 26, 2013 in Tulsa, Oklahoma.
2. On October 31, 2013, Wohali filed suit against Sheltered Wings, Inc. (“Wings”) in State Court in Oklahoma.
3. On November 1, 2013, Wohali filed Wohali’s Motion to Suspend herein.
4. Because Wohali’s Trial Period is ongoing and a deposition is scheduled for November 26, 2013, Wohali moves for an expedited ruling on Wohali’s Motion to Suspend.

5. Wings has no objection to an expedited ruling, however Wings requests the Court delay a ruling until after Wings files its brief in opposition to Wohali's Motion to Suspend. Wings' counsel stated Wings intends to file its brief in opposition by Friday, November 15, 2013.
