**MOTION FOR AN EXTENSION OF DISCOVERY
AND TRIAL DATES WITH CONSENT**

The discovery period in the above-captioned proceeding is currently set to close on March 28, 2016. Registrant Lego Juris A/S (hereinafter "Registrant") hereby submits this motion on consent to extend such date by ninety (90) days, or until June 27, 2016, and requests that all subsequent dates be reset accordingly.

In the last Order in this matter, dated January 8, 2016, the Board granted the parties' December 22, 2015 motion for an extension of dates. In doing so, the Board noted that any further requests for extensions would be subject to supporting such a request with a detailed report regarding the progress of settlement discussions.

Since January 8, 2016, the parties have reached an agreement in principle to settle this cancellation proceeding, and have exchanged written drafts articulating the settlement. The parties communicated on January 24th, February 2nd, February 22nd, February 26th, March 7th, March 14th and March 18th regarding settlement. Counsel for Petitioners is currently marking up the draft agreement and will provide comments to counsel for Registrant within a week's time. The parties believe that the proposed new schedule should be sufficient to allow them to

complete their settlement discussions in a timely manner, with neither side being prejudiced. The parties therefore jointly and respectfully request that the Board grant this motion.

The parties request that the Board re-set the remaining dates in this proceeding as follows:

Plaintiff's Rebuttal Disclosures: 12/08/2016




