CONSOLIDATED PETITION TO CANCEL

Petitioner, The Society of Certified Insurance Counselors, DBA The National Alliance for Insurance Education and Research, a Texas corporation, having an address at 3630 North Hills Drive, Austin, Texas 78731, hereby petitions for cancellation of the above registrations, and states as follows:

1. To the best of Petitioner's knowledge, the name appearing of record as current owner of U.S. Trademark Registrations No. 3,230,626 and No. 3,230,622 is MyPages.com, LLC, an Oregon limited liability company ("Registrant"). The address appearing of record is 4370 NE Halsey Street, Suite 217, Portland, Oregon 97213.

2. Petitioner believes that it will be damaged the registrations, and hereby petitions to cancel the registrations.

3. Petitioner owns pending U.S. Trademark Application No. 85/060,337 (“Petitioner’s Application”) for the mark MYPAGE (stylized design) for “Providing a website that gives registered users the ability to create customized web pages featuring user-defined information, namely, user name, address, telephone number, e-mail address and personal information, and updates, and topics of interest, certification course participation history and validation, certification status and updates, in the field of continuing education and certification for insurance and risk professionals; providing a web site featuring technology that enables users to make user-entry and editing of personal contact and personal information and selection of topics of interest, course participation history and validation, and certification status and updates; providing specific information requested by the customers, namely, registered users, via the Internet and in the fields of insurance and risk management.”

4. The grounds for the cancellation are that the Registrant, MyPages.com, LLC, has abandoned the marks of the Registrations.

5. On information and belief, MyPages.com, LLC, the Registrant, has dissolved in the records of the Secretary of State of Oregon.

6. Registrant has abandoned the mark due to nonuse, and does not intend to resume use of the mark.

WHEREFORE, Petitioner requests that U.S. Registrations No. 3,230,626 and No. 3,230,622 be cancelled.
