RESPONDENT'S MOTION TO SUSPEND PROCEEDINGS

Respondent, Emmanouil Kokologiannis and Sons S.A. (“Respondent”) moves the Trademark Trial and Appeal Board (“Board”), pursuant to Trademark Rule 2.127(d), 37 C.F.R. §2.127(d). for suspension of proceedings after the filing of a motion for summary judgment.

Respondent filed a motion for summary judgment in this proceeding on May 23, 2014, only a few days before Petitioner’s testimony period was set to begin.
