Petitioner in the above-identified cancellation proceeding, by and through its respective attorneys, hereby moves to suspend these proceeding pending resolution of the appeal of a judgment entered in an action based in Singapore among the parties related to ownership of the KU DE TA mark in Singapore (the "Appeal"). The instant cancellation proceeding is one of several disputes throughout the world related to the ownership of the KU DE TA mark and, after discussions among the parties, the parties agree that final resolution of certain factual issues in the Appeal could result in efficiencies in this cancellation proceeding and avoid unnecessary and duplicative litigation. The parties expect that the appeal will be resolved by the end of the year.

Accordingly, the Parties request that the Board suspend these proceedings until resolution of the Appeal. The Parties agree to notify the Board in writing of resolution of the Appeal and request resumption of this proceeding within two (2) weeks of the Appeal's resolution. Given that there is a possibility that the decision on Appeal could impact issues in this action, the parties would request that, upon resumption, the parties have two (2) months for completion discovery and disclosure of experts.

This motion is not made for purposes of delay. The parties request this suspension to avoid unnecessary duplicative litigation and to achieve judicial efficiency.

Registrant's attorney, Austin Padgett, agreed to the requested suspension in an e-mail dated February 9, 2014.
