

**STIPULATED MOTION FOR SUSPENSION FOR SETTLEMENT**

Pursuant to 37 C.F.R § 2.117(a) and T.B.M.P. § 510.02(a), L'Oreal USA, Inc. (the "Opposer") and Too Faced Cosmetics, LLC (the "Applicant")(collectively, the "Parties"), hereby stipulate to suspend Opposition Nos. 91-207,419 and 91-204,493 and Cancellation No. 92-056,303 for thirty (30) days pending settlement negotiations.

The Parties acknowledge that the above-proceedings have currently been suspended pending the disposition of an outstanding motion.
