Otto International (USA) LLC (“Petitioner”), a Delaware limited liability company with offices at 489 5th Avenue, 34th Floor, New York, New York 10017, United States, believes that it has been, is, and will continue to be injured by U.S. Registration No. 4,120,459, and hereby applies for cancellation of the same.

To the best of Petitioner’s knowledge, the name and address of the current owner of U.S. Registration No. 4,120,459 is Karmasu Technology Inc. (“Respondent”), 1020 Denman Street Vancouver V6G3E1, Canada.¹

The grounds for cancellation are as follows:

¹ Pursuant to Trademark Rule 2.111(b), Petitioner serves this Petition to Cancel on the owner of Registration No. 4,120,459.

FACTUAL ALLEGATIONS

1. Petitioner is a specialty retailer and licensor of home furnishings, decorations, accessories, and related products. Petitioner and its predecessor-in-interest—the Bombay Company—has achieved a reputation for providing high-quality products under the BOMBAY®, BOMBAY and Design®, BOMBAY KIDS®, BOMBAY KIDS and Design®, and THE BOMBAY COMPANY® marks (the “BOMBAY Marks”).

2. The BOMBAY Marks are part of a portfolio of heritage brands that begun with the Bombay Company’s establishment over three decades ago. The BOMBAY Marks are widely regarded as world-inspired luxury brands associated with premium quality furnishings and gifts. Products offered under the BOMBAY Marks may be purchased from a number of well-known U.S. retail stores across the country.

3. Petitioner owns U.S. Registration No. 1,272,741 for the BOMBAY word mark for “furniture and articles of wood consisting of tables, chairs, and accessory boxes” in Class 20, which registered on April 3, 1984, claiming a first use date of at least as early as June 18, 1975, for these goods. The underlying application was filed on June 14, 1982. This registration is incontestable. Attached hereto as Exhibit A are true and correct copies of the registration certificate and TSDR status report, including assignment history, for Registration No. 1,272,741.

4. Petitioner owns U.S. Registration No. 2,221,668 for the BOMBAY word mark for “electronic retailing services via computer, retail store services and mail-order catalog services in the field of furniture and accessories” in Class 35, which registered on February 2, 1999, claiming a first use date of at least as early as October 15, 1997, for these services. The underlying application was filed on January 28, 1998. This registration is incontestable. Attached hereto as Exhibit B are true and correct copies of the registration certificate and TSDR status report, including assignment history, for Registration No. 2,221,668.

5. Petitioner owns U.S. Registration No. 2,828,994 for the BOMBAY and Design mark, for “lamps, water fountains, electric coffee pots” in Class 11; “vases of precious metal, candle

holders of precious metal, candle snuffer and tray combination made in whole or part of precious metal, pillar candle plate made in whole or part of precious metal, sculptures made of precious metal, coffee pots of precious metal, tea pots of precious metal, salt shakers of precious metal, serving platter of precious metal, serving trays of precious metal, jewelry boxes of precious metal, clocks” in Class 14; “coasters made of paper, stationery, pens, pencils, desk pads, desk sets, desk stands and holders for pens, pencils, and ink, desk top document racks, desk top document stands, desk top organizers, desk top planners, desk top revolving rotary card files, desk top stationery cabinets, bookends, bookmarks” in Class 16; “furniture, sculptures made of wood, soft sculpture wall decorations, hampers, umbrella stands, picture frames, jewelry boxes not of metal, non-metal boxes, pillows, beds, mirrors” in Class 20; and “vases, candle holders not of precious metal, urns, cookie jars, glass storage jars, insulating jars, flower pots, bird baths, bird houses, porcelain sculptures, coffee pots not of precious metal, tea pots not of precious metal, tea sets, dinnerware, mugs, cups, plates, serving dishes, salt and pepper shakers, serving platters, pitchers, wicker baskets, wood baskets, coasters, non-metal decorative boxes” in Class 21, which registered on April 6, 2004, claiming a first use date of at least as early as October 1997 for these goods. The underlying application was filed on August 31, 2001. Attached hereto as Exhibit C are true and correct copies of the registration certificate and TSDR status report, including assignment history, for Registration No. 2,828,994.

6. Petitioner owns U.S. Registration No. 2,286,557 for the BOMBAY and Design mark, for “electronic retailing services via computer, retail store services and mail-order catalog services in the field of furniture and accessories” in Class 35, which registered on October 12, 1999, claiming a first use date of at least as early as October 1997 for these services. The underlying application was filed on January 28, 1998. This registration is incontestable. Attached hereto as Exhibit D are true and correct copies of the registration certificate and TSDR status report, including assignment history, for Registration No. 2,286,557.

7. Petitioner owns U.S. Registration No. 2,743,792 for the BOMBAY KIDS word mark, for “furniture, including chairs, loveseats, sofas, rockers, beds, ottomans, headboards, armoires, tables, bedside tables, desks, stools, dressers, rocking chairs, canopy beds, pedestals, storage pedestals, bookcases, chests, desks, computer desks, hutches, and drawer chests; home accessories, namely decorative mobiles, lockers, non metal nameplates, jewelry boxes not made of metal; mirrors, seating cubes, picture frames, wall storage units and wall shelf ledges, plastic dog door stoppers, magazine racks, pillow neck rolls, pillows, floor pillows, and applique pillows” in Class 20; “bedding, namely blankets, quilts, coverlets, blanket throws, bed skirts, bed curtains, dust ruffles, pillow shams, pillowcases, sheet and sheet sets, duvets, comforter and blanket covers, and bed canopies; window treatments, namely fabric valences, curtains, draperies, panels, swags and tie-backs” in Class 24; and “mail order and electronic catalog services featuring furniture, home accessories and gifts; on-line retail services in the field of furniture, home accessories and gifts” in Class 35, which registered on July 29, 2003, claiming a first use date of at least as early as August 7, 2001, for these goods and services. The underlying application was filed on July 20, 2001. Attached hereto as Exhibit E are true and correct copies of the registration certificate and TSDR status report, including assignment history, for Registration No. 2,743,792.

8. Petitioner owns U.S. Registration No. 2,765,062 for the BOMBAY KIDS and Design mark, for “furniture, including chairs, loveseats, sofas, rockers, beds, ottomans, headboards, armoires, tables, bedside tables, desks, stools, dressers, rocking chairs, canopy beds, pedestals, storage pedestals, bookcases, chests, desks, computer desks, hutches, and drawer chests; home accessories, namely decorative mobiles, lockers, non metal nameplates, jewelry boxes not made of metal; mirrors, seating cubes, picture frames, wall storage units and wall shelf ledges, plastic dog door stoppers, magazine racks, pillow neck rolls, pillows, floor pillows, and applique pillows” in Class 20; “bedding, namely blankets, quilts, coverlets, blanket throws, bed skirts, bed curtains, dust ruffles, pillow shams, pillowcases, sheet and sheet sets, duvets, comforter and

blanket covers, and bed canopies; window treatments, namely fabric valences, curtains, draperies, panels, swags and tie-backs” in Class 24; and “mail order and electronic catalog services featuring furniture, home accessories and gifts; on-line retail services in the field of furniture, home accessories and gifts” in Class 35, which registered on September 16, 2003, claiming a first use date of at least as early as August 7, 2001, for these goods and services. The underlying application was filed on July 20, 2001. Attached hereto as Exhibit F are true and correct copies of the registration certificate and TSDR status report, including assignment history, for Registration No. 2,765,062.

9. Petitioner owns U.S. Registration No. 1,999,211 for the THE BOMBAY COMPANY word mark, for “full line of furniture” in Class 20; “textiles and decorating accessories, namely tapestries, afghans, tablecloths and table coverings” in Class 24; and “games and decorative wooden game boxes, namely board games, dominos, card games, card holders, tic tac toe, poker chip caddy and chess/checker tables” in Class 28, which registered on September 10, 1996, claiming a first use date of at least as early as June 18, 1975, July 1988, and July 1988 for the goods in each class respectively. The underlying application was filed on February 7, 1995. This registration is incontestable. Attached hereto as Exhibit G are true and correct copies of the registration certificate and TSDR status report, including assignment history, for Registration No. 1,999,211.

10. Petitioner owns U.S. Registration No. 1,369,593 for the THE BOMBAY COMPANY word mark, for “retail store services for the sale of furniture and accessories” in Class 42, which registered on November 5, 1985, claiming a first use date of at least as early as January 1, 1978, for these services. The underlying application was filed on May 17, 1985. This registration is incontestable. Attached hereto as Exhibit H are true and correct copies of the registration certificate and TSDR status report, including assignment history, for Registration No. 1,369,593.

11. Petitioner and its predecessors-in-interest have offered and promoted their retail services and products under these various BOMBAY Marks for over three decades. Through

extensive use and promotion worldwide, Petitioner and its predecessors-in-interest have developed substantial goodwill and consumer recognition of the BOMBAY Marks as trademarks that uniquely identify their goods and services.

12. Through their widespread use and promotion of the BOMBAY Marks, Petitioner and its predecessors-in-interest have also acquired common law rights in the BOMBAY Marks. These marks are well known to and recognized by the public as identifying Petitioner's retail services and products.

13. On May 12, 2011, Petitioner applied for registration with the United States Patent and Trademark Office of its BOMBAY, BOMBAY and Design, BOMBAY KIDS, and BOMBAY KIDS and Design marks in connection with “[i]tems made in whole or part of precious metal, namely, sculptures, jewelry boxes, and clocks” in Class 14; “[s]tationery; pens; pencils; desk pads; desk sets; desk top organizers; desk top planners; bookends; bookmarks; and coasters made of paper” in Class 16; “[f]ull line of furniture” in Class 20; “[s]erving platters and trays” in Class 21; “[b]ed and table linen; wall hangings made of textile; fabric window coverings and treatments, namely, curtains, draperies, sheers, swags and valances” in Class 24; and “[o]nline retail store services and mail-order catalog services featuring furniture, house wares, home accessories, tableware, bed linens, wall décor, lighting and gift items” in Class 35. Petitioner's applications were assigned U.S. Application Serial Nos. 85/319,120; 85/319,124; 85/319,129; and 85/319,131 respectively (the “Applications”). Attached hereto as Exhibit I are true and correct copies of print-outs of the TSDR status reports for U.S. Application Serial Nos. 85/319,120; 85/319,124; 85/319,129; and 85/319,131.

14. The examining attorney assigned to the Applications (the “Examining Attorney”) refused to register Petitioner's BOMBAY, BOMBAY and Design, BOMBAY KIDS, and BOMBAY KIDS and Design under section 2(d) of the Lanham Act, citing U.S. Registration No. 4,120,459 for the BOMBAY BAGS word mark.

15. The Examining Attorney claims that the BOMBAY BAGS mark is so similar to the Applications' marks as to be likely to cause confusion, or to cause mistake, or to deceive. The Examining Attorney states that the BOMBAY BAGS mark shares the dominant term "Bombay" with Petitioner's BOMBAY Marks, and that the additional wording "bags" fails to distinguish the cited mark since "bags" is just a generic name for the products offered under the retail services associated with the cited mark.

16. The Examining Attorney also notes that the marks are used in connection with potentially identical services marketed to the same consumers through the same trade channels. The Examining Attorney contends that the Applications' service description—"online retail store services and mail-order catalog services featuring . . . *gift items*"—encompasses the "on-line retail store services featuring bags, clothing, fashion accessories" service description identified in U.S. Registration No. 4,120,459.

17. Respondent owns U.S. Registration No. 4,120,459 for the BOMBAY BAGS word mark, for "[o]n-line retail store services featuring bags, clothing, fashion accessories" in Class 35, which registered on April 3, 2012, based on Canada Registration No. TMA797434, which registered May 12, 2011. The underlying U.S. application was filed on January 15, 2011. Attached hereto as Exhibit J are true and correct copies of the registration certificate and TSDR status report for Registration No. 4,120,459.

18. Four of *Petitioner's registrations* (U.S. Registration Nos. 1,369,593; 2,221,668; 2,286,557; and 2,828,994) had been cited against Respondent's BOMBAY BAGS mark on the basis of likelihood of confusion during the prosecution of the BOMBAY BAGS mark.

19. Petitioner's initial BOMBAY Marks were filed and registered substantially prior to Respondent's filing and registration of its BOMBAY BAGS mark.

20. Petitioner's prior registrations for the BOMBAY Marks include the same word and design marks (BOMBAY, BOMBAY and Design, BOMBAY KIDS, and BOMBAY KIDS and Design) as the marks that are the subject of the Applications. If, as the Examining Attorney

contends, the BOMBAY, BOMBAY and Design, BOMBAY KIDS, and BOMBAY KIDS and Design marks are highly similar to Respondent's BOMBAY BAGS mark, these similarities would render consumer confusion highly likely.

21. Petitioner's prior registered BOMBAY Marks also cover "on-line retail services" related to the sale of various items including "*accessories*" and "*gifts*." If, as the Examining Attorney contends, "gift items" encompass the products featured in Respondent's retail services (bags, clothing, and fashion accessories) under the BOMBAY BAGS mark, then Respondent and Petitioner will offer competing services through the same or similar channels of trade, and target the same or overlapping customer bases under similar marks.

22. If the Examining Attorney's assessments are correct, Respondent's U.S. Registration No. 4,120,459 for the BOMBAY BAGS mark so resembles Petitioner's prior registered BOMBAY Marks when used in connection with Respondent's services as to be likely to cause confusion, or to cause mistake, or to deceive.

23. U.S. Registration No. 4,120,459 therefore should be canceled if the BOMBAY BAGS mark is likely to be confusingly similar with Petitioner's BOMBAY Marks because Petitioner has prior rights in the BOMBAY Marks.

PRAYER FOR RELIEF

WHEREFORE, Petitioner prays that U.S. Registration No. 4,120,459 be canceled.


